## New Employee Pre-Appointment Security Package

#### Introduction

This employee pre-appointment security package contains the personnel Form 306, Office of Personnel Management which must be competed prior to a firm commitment of employment at the United States Patent and Trademark Office.

Complete the form manually. Review for accuracy before you sign and return to the USPTO. As a convenience to you, the Acrobat Reader software allows you to type your information, but will not allow you to save the document, so please keep a copy of the document.

Print the document as you complete it so data is not lost. When you print, make sure the "fit to page" option is selected in the print properties box.

Trustworthiness is an important consideration in deciding your suitability. The information you provide will be verified. Negative information provided on your application does not necessarily preclude you from being hired. Negative information will be reviewed on a case by case basis and adjudicated per Office of Personnel Management (OPM) standards.
