**EXECUTIVE SUMMARY**

The Department of Defense (DoD) Freedom of Information Act (FOIA) program is reporting 71,699 processed requests for records under the FOIA. In the processing of these cases, the Department of Defense granted in full 28,451, partially denied 14,901, and denied in full 2,554 on the basis of FOIA exemptions. Of all the cases in which the exemptions were used, approximately 38% were for privacy information (Exemption 6); 19% for law enforcement privacy (Exemption 7(C)); 10% for internal rules and practices; 8% for statutory exemptions; 8% for classified information; 8% for deliberative material; 6% for proprietary data; 3% for law enforcement investigations (not including Exemption 7(C)); 0.03% for information concerning financial institutions and 0.03% for information concerning wells. An additional 25,793 requests were closed in whole or in part for other reasons, such as lack of records, referral to another agency, or lack of specificity sufficient to identify the requested records. There were 862 actions taken on appeals of denied requests: 37 reversed, 138 partially affirmed, 245 fully affirmed, and 442 dismissed for other reasons. The number of pending FOIA requests at the DoD at the end of fiscal year 2007, as reported in last year's report, was 26,195. The number of pending FOIA requests for the DoD at the end of fiscal 2008 year was 14,660. The greater part of this reduction in backlog can be attributed to the change in reporting requirements of Privacy Act requests. However, even considering the change in reporting requirements, the DoD reduced its overall backlog by 3% in FY 2008, which can be attributed to the additional funding selected DoD components were directed to apply to their FOIA programs, in accordance with the DoD FOIA Improvement Plan of June 14, 2006.

The total DoD operating cost associated with the processing of requests during this report period was \$70,755,178. The average cost of processing a single case during this period was approximately \$986.00. Fee collections for records provided to the public amounted to \$617,878 (0.9% of total program cost).

Due to significant reporting requirements for the annual report that were not established until mid-year FY08, not all 30 components were able to collect and satisfy the new data requirements despite significant efforts to do so.

2. Reasons why some requests are not granted and general categories of agency records.
  - a. This is a summary of the most frequent reasons for a FOIA request to not be granted:
    - i. The request is transferred to another DoD component, or to another Federal Agency.

- ii. The request is withdrawn by the requester.
  - iii. The requester is unwilling to pay fees associated with a request; the requester is past due in the payment of fees from a previous FOIA request; or the requester disagrees with the fee estimate.
  - iv. A record has not been described with sufficient detail to enable the DoD component to locate it with a reasonable amount of effort.
  - v. The information requested is not a record within the meaning of the FOIA.
  - vi. The request is a duplicate request (e.g., a requester asks for the same information more than once). This includes identical requests received via different means (e.g., electronic mail, facsimile, mail, courier) at the same or different times from the same requester.
  - vii. The record is denied in whole or in part in accordance with one or more exemptions as set forth in the FOIA.
- b. The FOIA exemptions used by the DoD components apply to a number of different categories of records. Some of these categories are:
- i. Acquisition and Contracting
  - ii. Personnel
  - iii. Intelligence
  - iv. Military/Operational
  - v. Law Enforcement
  - vi. Inspector General

## 2. Definitions of terms.

- a. **Administrative Appeal:** A request to an agency asking that it review at a higher administrative level a full denial or partial denial of access to records under the FOIA, or any other adverse FOIA determination.
- b. **Average number:** The number obtained by dividing the sum of a group of numbers by the quantity of numbers in the group. For example: the average of 3, 7, and 14 is 8.
- c. **Backlog:** The number of requests or administrative appeals that are pending at an agency at the end of the fiscal year that are beyond the statutory time period for a response.
- d. **Component:** DoD processes requests on a decentralized basis; a “component” is an entity, also sometimes referred to as an Office, Combatant Command, or Defense Agency, within DoD that processes FOIA requests.
- e. **Consultation:** The procedure whereby an agency responding to a FOIA request first forwards a record to another agency for its review because that other agency has an interest in the document. Once the agency in receipt of the consultation finishes its review of the record, it responds back to the agency that forwarded it. That agency, in turn, will then respond to the FOIA requester. The DoD tracked consultations as FOIA requests until July 1, 2008. Due to DOJ guidance, they are now tracked and reported separately.
- f. **Exemption 3 Statute:** A separate federal statute prohibiting the disclosure of a certain type of information and authorizing it being withheld under FOIA, 5 USC 552(b)(3).
- g. **FOIA Request:** A FOIA request is generally a request to an agency for access to records concerning another person (i.e. a “third-party” request), or concerning an organization, or a particular topic of interest. FOIA requests also include requests made by requesters seeking records concerning themselves (i.e., “first-party” requests) when those requesters are not subject to the Privacy Act, such as non-U.S. citizens. Moreover, because all first-party requesters should be afforded the benefit of both the access provisions of the FOIA as well as those of the Privacy Act, FOIA requests also include any first-party requests where an agency determines that it must search beyond its Privacy Act “systems of records” or where a Privacy Act exemption applies, and the agency looks to FOIA to afford the greatest possible access. All requests which require the agency to utilize the FOIA in responding to the requester are included in this report.
- h. **Full Grant:** An agency decision to disclose all records in full in response to a FOIA request.
- i. **Full Denial:** An agency decision not to release any part of a record or records in response to a FOIA request because all the information in the requested record or records is determined by the agency to be exempt under one or more of the FOIA exemptions, or

for some procedural reason such as no record is located in response to a FOIA request.

- j. **Median number:** The middle, not average, number. For example, of 3, 7, and 14, the median number is 7.
- k. **Multi-track processing:** A system in which simple requests requiring relatively minimal review are placed in one processing track and more voluminous and complex requests are placed in one or more other tracks. Requests in each track are processed on a first-in/first out basis. A requester who has a compelling need for records may request expedited processing (see below).
  - i. **Expedited Processing** – an agency will process a FOIA request on an expedited basis when a requester satisfies the requirements for expedited processing as set forth in the statute and in agency regulations.
  - ii. **Simple Request** – a FOIA request that an agency using multi-track processing places in its fastest (non-expedited) track based on the low volume and/or simplicity of the records requested.
  - iii. **Complex Request** – a FOIA request that an agency using multi-track processing places in a slower track based on the high volume and/or complexity of the records requested.
- l. **Partial Grant/Partial Denial:** An agency decision to disclose a record only in part in response to a FOIA request, deleting information determined to be exempt under one or more exemptions under the FOIA; or a decision to disclose some records in their entirety, but to withhold others in whole or in part.
- m. **Pending Request or Pending Administrative Appeal:** A request or administrative appeal for which an agency has not taken final action in all respects.
- n. **Perfected Request:** A request for records which reasonably describes such records and is made in accordance with published rules stating the time, place, fees (if any) and procedures to be followed.
- o. **Processed Request or Processed Administrative Appeal:** A request or administrative appeal for which an agency has taken final action in all respects.
- p. **Range in Number of Days:** The minimum and maximum number of days to process requests or administrative appeals.
- q. **Time limits:** The time period in the FOIA for an agency to respond to a FOIA request (ordinarily 20 working days from proper receipt of a "perfected" FOIA request).

### 3. Short definitions of the nine FOIA exemptions:

- a. **Exemption 1:** classified national defense and foreign relations information



- b. **Exemption 2:** internal agency rules and practices
- c. **Exemption 3:** information that is prohibited from disclosure by another federal law
- d. **Exemption 4:** trade secrets and other confidential business information
- e. **Exemption 5:** inter-agency or intra-agency communications that are protected by legal privileges
- f. **Exemption 6:** information involving matters of personal privacy
- g. **Exemption 7:** records or information compiled for law enforcement purposes, to the extent that the production of those records (A) could reasonably be expected to interfere with enforcement proceedings, (B) would deprive a person of the right to a fair trial or an impartial adjudication, (C) could reasonably be expected to constitute an unwarranted invasion of personal privacy, (D) could reasonably be expected to disclose the identity of a confidential source, (E) would disclose techniques and procedures for law enforcement investigations or prosecutions, or would disclose guidelines for law enforcement investigations or prosecutions, or (F) could reasonably be expected to endanger the life or physical safety of any individual
- h. **Exemption 8:** information relating to the supervision of financial institutions
- i. **Exemption 9:** geological information on wells

## V. FOIA Requests

It should be noted that in the middle of the FY 08 reporting cycle, the DOJ changed the reporting requirements and directed agencies to no longer count pure Privacy Act (PA) requests as FOIA requests. See the footnote, below, on how this change impacted the numbers reported in Table 2.

## **VII. FOIA Requests: Response Time for Processed and Pending FOIA Requests**

Due to the decentralized processing and tracking of FOIA requests within the DoD and because the DoD does not have the means to centrally capture all the required data, it is not possible to calculate DoD medians and the medians for some components that have more than one FOIA requester service center. Air Force database problems led to the exclusion of some data. The DoD is currently working on having a new data collection system in place for the FY 09 Report.

Historically, the DoD has not tracked “consultations” separately from FOIA requests. The Department of Justice directed agencies to track and report on consultations separately beginning July 1, 2008, if feasible. On that date, some DoD components were able to retroactively determine which of their open FOIA requests were “consultations;” however, most did not. At the end of FY 08, some components still were not able to configure their data tracking systems to account for consultations. All components are now tracking consultations separately.
