

FEDERAL STRATEGIC PLAN DEVELOPMENT PROCESS DESCRIPTION

DEVELOPMENT OF THE PLAN

The President and Congress charged the U.S. Interagency Council on Homelessness (USICH) with the development of a “national strategic plan” to end homelessness with enactment of the Homeless Emergency Assistance and Rapid Transition to Housing (HEARTH) Act in May 2009. As a result, USICH has developed the Federal Strategic Plan to Prevent and End Homelessness. This plan reflects agreement by the agencies on the Council on a set of priorities and strategies including activities initiated by the President in the budget for fiscal years 2010 and 2011.

The Council affirmed six core values to be reflected in the plan:

- Homelessness is unacceptable.
- There are no “homeless people,” but rather people who have lost their homes who deserve to be treated with dignity and respect.
- Homelessness is expensive; it is better to invest in solutions.
- Homelessness is solvable; we have learned a lot about what works.
- Homelessness can be prevented.
- There is strength in collaboration and USICH can make a difference.

The Council decided the **development of the Plan should be guided by key principles.**

It should be:

- Collaborative
- Solutions-driven and evidence-based
- Cost-effective
- Implementable and user-friendly
- Lasting and scalable; and
- Measurable, with clear outcomes and accountability

AN OPEN AND COLLABORATIVE PROCESS

We stressed the importance of transparency. We encouraged multiple opportunities for input, feedback, and collaboration in the development of the Plan from researchers, practitioners, state and local government leaders, advocates, people who have experienced homelessness, and federal agency staff. All input helped to inform the Plan’s priorities and strategies.

1. FEDERAL AGENCY WORKGROUPS AND EXPERTS PANEL

Five workgroups were convened to analyze specific populations:

- **The Chronically Homeless Workgroup** focused its work on the prevention and elimination of homelessness among individual adults with chronic health conditions experiencing long-term or recurrent homelessness.
- **The Veterans Workgroup** focused its work on the prevention and elimination of homelessness among adults who have served in the armed forces and their families.
- **The Families Workgroup** focused its work on the prevention and elimination of homelessness among families with children. “Families” are broadly defined and inclusive of a range of family structures.
- **The Youth Workgroup** made a special inquiry into the needs of youth who are homeless or at risk of becoming homeless, covering both those who are with their families and youth who are unaccompanied.
- **The Community Workgroup** examined states’ practices in mobilizing community participation, forging partnerships and aligning resources that have been effective in addressing homelessness. It looked across all populations.

Members of the workgroups were designated by members of the U.S. Interagency Council on Homelessness’ Policy Group from within their respective agencies. Experts on the panel included people with personal experience of homelessness, researchers, state & local government leaders, practitioners, and advocates.

These expert panel meetings were held in February 2010 where workgroup members reviewed the expert’s literature and talked with experts for additional insights. Some of the written recommendations received from the different experts on the panel can be found on our website as a supplement to *Opening Doors: The Federal Strategic Plan to Prevent and End Homelessness*.

2. EXTERNAL STAKEHOLDER INPUT

We highly value the experience and expertise of those who have first-hand experience with homelessness, professionals and volunteers who work daily on this issue and local and state policy makers. We obtained input from more than 750 leaders of regional and state interagency councils and stakeholders from across the country during regional meetings held in February and early March. Regional stakeholder dialogues were held in different cities as outlined below:

These were one-day events divided into two sessions. 1) Regional Federal Interagency Council Members, together with USICH, hosting a meeting with the Chair of each State Interagency Council on Homelessness within the region and each State Homeless Education Coordinator. 2) A broad range of community stakeholders were invited to a meeting facilitated by USICH. These meetings were a great opportunity for USICH to hear directly from external and federal government stakeholders regarding challenges, priorities and different perspectives on how to prevent and end homelessness in the United States.

Online Comment Forum

USICH created an interactive website (<http://fsp.uservoice.com>) for the public to comment on the different themes of the Federal Strategic Plan to Prevent and End Homelessness. HUD also posted a guest blog entry by Executive Director Barbara Poppe that invited people to comment on the site. The online comments and activity surpassed our expectations:

- The site attracted 7,734 visits
- 2,318 individual comments were recorded

THE FEDERAL STRATEGIC PLAN TO PREVENT AND END HOMELESSNESS

In the plan, USICH jointly created –

- A set of targeted, solutions-driven goals and collaborative strategies;
- A roadmap for joint action to guide the development of programs and budget proposals toward a set of measurable targets; and
- A set of priorities the agencies will pursue over the five year period – FY 2010 through FY 2014

USICH centered its plan on the belief that “no one should experience homelessness – no one should be without a safe, stable place to call home.” The plan is focused on four key goals: 1) Finish the job of ending chronic homelessness in five years; 2) Prevent and end homelessness among Veterans in five years; 3) Prevent and end homelessness for families, youth, and children in ten years; and 4) Set a path to ending all types of homelessness. We look forward to working with federal, private, and non-profit organization to work together to make that belief a reality for each homeless person in our nation.
