SUBJECT: Use of USNH Okinawa Consult and Referral Services

1. In an effort to keep WESTPAC patients utilizing the closest capable facility, USNH Okinawa (USNHO) will have the right of first refusal for services they can support. At this time, this policy will apply for referrals from South Korea and Japan based MTFs; Guam based MTFs may be added at a later date.

2. The list of USNHO's currently available services can be found at

This list will be updated at least monthly. MTFs from Japan and Korea should contact USNHO for referrals in the listed specialties before requesting a patient movement to Tripler Army Medical Center or CONUS.

3. Effective 1 September 2008, TPMRC will require an over flight letter for patients going past USNH Okinawa in those specialties which they can support. This request should be emailed to both:

a. the USNHO organizational box: NHOKI-OverflightApproval@med.navy.mil b. the TPMRC organizational box: dl.13af.sg.tpmrc.all@hickam.af.mil

U.S. NAVAL HOSPITAL OKINAWA RIGHT OF FIRST REFUSAL/OVERFLIGHT POLICY

Background: As the largest military treatment facility in the Western Pacific, US Naval Hospital Okinawa is able to provide specialty services that are not available at smaller MTF's in the AOR. Furthermore, the distance to Okinawa from MTF's in the Western Pacific is significantly less than it is to Hawaii or CONUS, thus offering savings in time and transportation costs for aeromedical evacuations. Therefore, USNH Okinawa is well suited to accept patients requiring specialty care from other Western Pacific MTF's.

Policy:

1. USNH Okinawa reserves the right to (a) review, and (b) accept or refuse all specialty care referrals received from the Western Pacific AOR for services that are listed as available on the "US Naval Hospital Okinawa Service Availability Report" (SAR) and that would otherwise be sent to TAMC or a CONUS facility.

2. The following procedures should be followed by MTF's in Japan or Korea when it is necessary to aeromedically evacuate a patient for medical treatment:

a. Using the USNH Okinawa "Service Availability Report" (SAR), determine if the required service is available at USNH Okinawa. If there is any question about the availability of services, call the applicable specialist using the phone number on the SAR.

b. If, according to the SAR, the required service is not available, it is not necessary to submit an Overflight request. When submitting the Patient Movement Request (PMR) to TPMRC, clearly state that according to the USNH Okinawa SAR, the service is not available.

c. If the service is available but transport of the patient to Okinawa is not a viable option based on the patient's medical condition or other factors (personal, logistical, etc), or if the appropriate specialist at Okinawa states by phone or e-mail that the patient can't be seen within the required period of time, then transmit an Overflight request letter (see below).

d. If the service is available and there is no compelling reason to request Overflight, then follow the current established TPMRC procedures for arranging aeromedical evacuation. Specifically, take the following action:

1) For "ASAP" consults, direct verbal approval from the accepting physician at USNH Okinawa is required. Contact information for each specialty is on the SAR Report.

2) For routine consults, approval from the accepting physician through the CHCS consult process is required. Direct contact with the appropriate specialist at USNH Okinawa is encouraged when deemed necessary by the referring provider.

e. If the patient can be accepted by USNH Okinawa, follow the appropriate steps for arranging aeromedical evacuation. If the patient can not be accepted, then transmit an Overflight request letter (see below).

3. An Overflight request letter should be transmitted (with justification) to:

a) NHOKI-OverflightApproval@med.navy.mil

b) dl.13af.sg.tpmrc.all@hickam.af.mil

Also after normal working hours, call the cell phone number that is listed on the SAR to advise the watchstander of the request. The USNH Okinawa Overflight Approving Official will either agree with the request and endorse it, or recommend disapproval. Disapproval will normally only occur in cases where the service is available at USNH Okinawa and the referring MTF fails to provide appropriate justification for an Overflight.

Mrs. Doe has been evaluated here at USNH Yokosuka, Japan and by Dr. Higa at Tokyo Metropolitan Hiroo Hospital. She is in need of an endoscopic ultrasound and biopsy of this mass and possible subsequent surgery which we have not been able to perform.
