The purpose of this alert is to provide clarification on the WAWF exception at DFARS 232.7002(a)(4) for contract awards awarded by deployed Contracting Officers in the course of military operations, including but not limited to contingency operations as defined in 10. U.S.C. 101(a)(13) or humanitarian or peacekeeping operations as defined in 10 U.S.C. 2302(8), or contracts awarded by contracting officers in the conduct of emergency operations, such as responses to natural disasters or national or civil emergencies.
- 2. Background: One of the CSB's requested clarification regarding the

PARC/Policy Alert #11-53, Wide Area Workflow Class Deviation. To summarize, with the removal of the exception at DFARS 232.7002(a)(2), would OCONUS military exercises be considered "military operations" under the exemption at DFARS 232.7002(a)(4)?
