FOLLOWING INFORMATION FROM THE RECORDS OF THE POLICE IMPOUND LOT:
CAPTAIN MC CABE STATED THAT THE RECORDS REFLECT A 1973 DODGE DART, NEW YORK LICENSE 219Z14, OWNED BY OLINS RENT-A-CAR, 3700 WEST OCEANSIDE AVENUE, OCEANSIDE, NEW YORK, WAS ON MARCH 5/73 AT APPROXIMATELY 3:35 PM TICKETED SUMMONS NUMBER 27-478878-0. THE SUMMONS WAS ISSUED BY PARKING ENFORCEMENT AGENT ELIZABETH HIGGINS FOR VIOLATION OF OFFICIAL DEPARTMENT TRAFFIC SIGNS WHICH READ "NO STANDING 1 PM TO 7 PM EXCEPT SUNDAY". THE VEHICLE WAS LOCATED AT EAST 43RD STREET AND FIFTH AVENUE. THE VEHICLE WAS TOWED AT 3:35 PM APPROXIMATELY THE SAME TIME BY MOTOR VEHICLE OPERATOR ARTOPEE JUDGE AND STORED AT PIER NUMBER 95, SECTION 1B, AND RECEIVED SERIAL NUMBER 10935.

CAPTAIN MC CABE STATED THE RECORDS REFLECT A 1972 PLYMOUTH DUSTER, NEW YORK LICENSE 472391 WAS TICKETED SUMMONS NUMBER 29980704-5 BY PATROLMAN HEARVE, MIDTOWN NORTH PRECINCT, FOR VIOLATION OF OFFICIAL DEPARTMENT OF TRAFFIC SIGN WHICH READ "TAXI STAND" AT THE WEST SIDE OF EAST 47TH STREET AND FIFTH AVENUE. THIS SUMMONS WAS ISSUED AT 8:10 AM, MARCH 6/73 AND TOWED AT APPROXIMATELY THE SAME TIME BY MOTOR VEHICLE OPERATOR NICHOLAS VENTO, SERIAL NUMBER 11028, TO PIER NUMBER 95, NYCPD IMPOUND LOT.

MR. BILL MACKLIN, OLIN RENT-A-CAR, FIRST AVENUE AND 38TH STREET, NEW YORK CITY, FURNISHED THE FOLLOWING INFORMATION FROM RENTAL CAR CONTRACT NUMBER F123517. THIS CONTRACT REFLECTS THAT AID YOUSIF SHAHN, 351 WEST 42ND STREET, NEW YORK CITY, POSSESSING AN INTERNATIONAL DRIVERS LICENSE WITH AN EXPIRATION DATE OF DECEMBER, 1973, AND A DATE OF BIRTH OF JULY 1/45, DID RENT CAR NUMBER 31601, A 1973 DODGE DART, NEW YORK LICENSE NUMBER 219Z14, AT 1:51 PM, MARCH 2/73. THE MILEAGE AT CHECK OUT TIME WAS LISTED AT 1783 AND SHAHN LEFT A SEVENTY-FIVE DOLLAR DEPOSIT FOR THE ABOVE CAR RENTAL. IT WAS NOTED ON RENTAL CONTRACT THAT THERE WOULD BE "NO OTHER DRIVER".

MACKLIN STATED THAT SHAHN REMAINED IN THE RENTAL OFFICE FOR APPROXIMATELY 15 MINUTES AND STATED HE BELIEVED SHAHN TALKED WITH AN ACCENT BUT WAS UNCERTAIN AS TO THE NATURE OF THE ACCENT. HE DESCRIBED SHAHN AS A WHITE MALE WITH BLACK HAIR, THIN, WITH SHARP FACIAL FEATURES, 5 FT 8 INCHES TO 5 FEET 9 INCHES, 28-30 YEARS OF AGE

IN ADDITION, MACKLIN STATED SHAHN EXECUTED IN HIS OWN HAND A PERSONAL DATA FORM REQUIRED BY THE OLIN RENT-A-CAR COMPANY WHICH SET FORTH THE FOLLOWING INFORMATION:

EFRAIN LOPEZ ADVISED THAT HE RECALLED RENTING OUT THIS PARTICULAR AUTOMOBILE AND RECALLED Y. SHAHEIN JABAL AS BEING IN PAGE SIX DE RUEHFB #0595 UNCLAS HIS MID TWENTIES, COMPLEXION LIGHT TAN, HEIGHT 5 FEET 10 INCHES - 5 FEET 11 INCHES, WEIGHT APPROXIMATELY 170, HAVING THICK BLACK HAIR, PARTED ON THE SIDE, HAVING LONG SIDEBURNS. HE WAS WEARING A BLUE SPORTS COAT, BELLBOTTOM TROUSERS - EITHER LIGHT BLUE OR GREY, AND WAS CARRYING

A CAMERA. HE SPOKE EXCELLENT ENGLISH WITH A SLIGHT ACCENT, WAS VERY AFFABLE, AND APPEARED WELL EDUCATED AND WELL VERSED IN INTERNATIONAL AFFAIRS. LOPEZ RECALLED HIM STATING THAT HE WAS JUST VISITING AND THAT HE WOULD BE AROUND FOR A FEW DAYS.

THE CHECK OUT MILEAGE WAS LISTED AS 516 AND A ONE HUNDRED DOLLAR CASH DEPOSIT WAS ACCEPTED AS A DOWNPAYMENT ON THIS RENTAL.

MISS MOLNAR FURNISHED THE FOLLOWING PHYSICAL DESCRIPTION OF SHAHIN:

DARK EYES, WEARING A MEDIUM LENGTH SPORT JACKET AND SPOKE WITH A FOREIGN ACCENT WHICH SHE COULD NOT IDENTIFY. MISS MULNAR STATED THAT SHE FELT CERTAIN SHE COULD IDENTIFY THIS INDIVIDUAL IF SHE SHOULD

SEE HIM AGAIN.

AN UNIDENTIFIED MALE WHO ADVISED HE HAS RESIDED IN AREA FOR 35 YEARS STATED THERE WAS NO ONE IN THE NEIGHBORHOOD WITH AN ARABIC BACKGROUND TO HIS KNOWLEDGE.

NO RECORD OF A TUNNEL AVE. COULD BE LOCATED IN JERSEY CITY,, NEW JERSEY; HOWEVER THERE IS A TONNELE AVENUE AND A CHECK AT 106 TONNELE AVENUE REFLECTED THIS ADDRESS IS ONE OF 12 UNITS IN A GARDEN APARTMENT COMPLEX.

MRS. RAY BARTOSHEK, SUPERINTENDENT FURNISHED THE IDENTITIES OF ALL TENANTS, NONE WERE IDENTIFIABLE WITH INDIVIDUALS OF INTEREST TO BUREAU NOR COULD BARTOSHEK FURNISH ANY INFORMATION CONCERNING NAMES OF INTEREST TO BUREAU.
