- A. The term "documents" as used herein refers to all written or graphic matter, however produced or reproduced, of every kind and description in the actual or constructive possession, custody, care or control of the responding party, or any of its representatives, including but not limited to papers, letters, e-mail, photographs, correspondence, memoranda, inter-office communications, reports, studies, surveys, contracts, agreements, working papers, daily reports, plans, drawings, change orders, computer printouts, magnetic tapes, magnetic discs, notes or sound recordings of any conversations, notes of meetings or conferences, and minutes of any meetings.
- B. The term "RFQ" as used herein refers to all aspects of the Request for Quotation Number 00029885 with an issue date of 07/07/2011 and a Due Date of 07/21/2011, with a description as follows: "Container, Dumpster, Front Load Cardboard Recycling Containers, Standard Blue Paint, Plastic Lid, Auto-Release Lid Lock, No Casters". Manufacturer: Western Systems & Fabrication, Model: WSF-FL6CRFT, Part: FL6CRFT-MSAH-1".
 - C. The term "DOE" as used herein refers to the U.S. Department of Energy.
- D. The term "MSA" as used herein refers to Mission Support Alliance, LLC, which consists of the team of Lockheed Martin, Jacobs Engineering Group, and Wackenhut Services, Incorporated, the prime contractor overseeing Hanford's Mission Support Contract.
- E. In responding to this Freedom of Information Act Request, DOE and/or its agent MSA is required to produce documents in its possession, custody, or control, or in any of its offices or branches, or otherwise available to its employees, including, without limitation by reason of enumeration, documents in the possession of its attorneys or their investigators, or in

the possession of its advisors, agents, investigators, engineers, accountants, consultants, or associates whether past or present.

- F. If any document is withheld under claim of privilege, or exemption, the privilege or exemption involved shall be stated and each document shall be identified by date, author and subject matter (without disclosing its contents) sufficient to allow its description to the Court for ruling thereon.

- 4. All documents regarding the evaluation of the bids/responses to the RFQ and the determination of the low responsive and responsible bidder.

- 5. All documents and/or records of communications between DOE and MSA regarding the RFQ.
- 6. All documents and/or records of communications between DOE or MSA and Western Systems & Fabrication, Inc. regarding the RFQ.
- 7. All documents and/or records of communication between DOE or MSA and Columbia Rigging Corporation.
