Environmental Health Officers in Public Health:

- Provide leadership and support to public health programs designed to protect the public from exposure to hazardous substances.
- Provide services in disease prevention, environmental health, injury prevention, health promotion and education, and occupational safety.




# Why you should be an Environmental Health Officer in the U.S. Public Health Service Commissioned Corps

### **USPHS Commissioned Corps Officer Benefits**

Commissioned Corps officers working for the U.S. Public Health Service enjoy the same benefits as their counterparts in the armed services. Here are a few of them:

- No cost, comprehensive medical and dental care for Corps officers; excellent health benefits for families
- · Paid sick leave, maternity leave, and Federal holidays
- Clinical practice liability coverage
- Thirty days of paid vacation per year beginning the first year
- Tax-free housing and meal allowances
- Thrift Savings plan (retirement savings and investment plan similar to a 401 (k)
- Retirement plan with benefits eligibility beginning after 20 years of service
- Loan repayment potential USPHS understands the financial burden of medical education. Assignments with certain Federal agencies, such as the Indian Health Service, offer loan repayment and/or other educational and family support programs.
- Veterans Affairs benefits, such as the Montgomery GI Bill (MGIB) which allows active duty members to enroll and pay \$100 per month for 12 months; and are then entitled to receive a monthly education benefit once they have completed a minimum service obligation.

### U.S. Public Health Service Commissioned Corps Next Steps

#### **USPHS Officer Qualifications**

All Commissioned Corps officers must meet several basic qualifications: You must be a U.S. citizen, be less than 44 years of age, and pass a physical examination. To be an Environmental Health Officer, you also need the following:

- A candidate must possess a qualifying degree or a degree and professional certification in one of the following:
- A bachelors, masters, or doctoral degree in environmental health accredited by the National Environmental Health Science and Protection Accreditation Council, http://www.ehacoffice.org;
- A bachelors, masters, or doctoral degree in the curricular areas of industrial hygiene, safety, or health physics that is accredited by the Accreditation Board for Engineering and Technology, http://www.abet.org;
- A masters or doctoral degree with a specialization in environmental health, occupational health, or industrial hygiene from a school of public health that is accredited by the Council on Education for Public Health, http://www.ceph.org;
- A bachelors, masters or doctoral degree in any field and one of the following: Certification as an Industrial Hygienist (CIH) by the American Board of Industrial Hygiene, http://www.abih.org/; Certification as an Health Physicist (CHP) by the American Board of Health Physics, http://www.hps1.org/aahp/.

### **Environmental Health Student Opportunities**

The U.S. Public Health Service Commissioned Corps offers two excellent opportunities for students to serve their country while completing their education. 
