Subject: **Transcript of BBG Meeting at 12:00 P.M. EDT on August 17, 2012**

ASHE: Mr. Chairman, I would move in light of the prior discussion that the Board directs the Strategy and Budget Committee to review the issue of PNN and report back to the Board as expeditiously as possible.

SONENSHINE: Second.

ASHE: You probably need a vote just for the record.

LYNTON: All in favor?

ALL: Aye.

LYNTON: Opposed? Okay, that's passed.

ASHE: Unanimous.

LOBO: So you want to postpone the decision about that memo or the letter till later on?

SONENSHINE: I would ask to defer it to the next Board meeting.

LYNTON: Yes.

LOBO: That's the middle of September.

MEEHAN: Or can we have a committee work on it in the meantime or not?

SONENSHINE: I think we ought to talk about the formation of a committee at the next meeting so don't just jumble something together.

ASHE: Right, and I think there is a general thought, remember this is being recorded, that maybe we want to de-politicize it as much as possible. And maybe waiting until after we know the identity of the next President might be preferable.

LYNTON: Yeah.

MULHAUPT: I got to sign off, I'm afraid, now.

LYNTON: I do as well.

MEEHAN: Bye Dennis. Bye Michael, thanks.
