DESCRIPTION OF CHANGE: R&D Quarterly Report and Groundwater Plan

The Contractor shall:

Pursuant to Section C, Subparagraph C.3.1, "Project Management," CH2M HILL Plateau Remediation Company (CHPRC) is required to provide all management and technical information necessary to support DOE information needs. The government requires CHPRC to provide contract-specific Research and Development Plans and Reporting, as described in the attached memorandum dated August 4, 2010, from Dae Chung, Principal Deputy Assistant Secretary for Environmental Management, "Direct and Indirect Funded Research and Development Plans and Quarterly Progress Report".

The government considers the development of a plan and the content of the requested report to be consistent with Project Management responsibilities contained in Section C.3, "Description of Project Support Performance Requirements," specifically subparagraphs C.3.1.2, "Project Scope, Schedule, and Cost Baseline," and C.3.1.3, "Project Performance Reporting."

The following limitations to this Change Order:

As stipulated in Change Order 084, CHPRC shall proceed with work not to exceed \$400,000 from base funds in accordance with Clause B.3 "Obligation and Availability of Funds," prior to the definitization of this change in accordance with the referenced clause:
