This modification makes the following changes:

1. Defines Change Order 36 as all work necessary to disposition legacy CERCLA Waste as well as deactivation and disposition of the hose in hose system which transferred 100-K Area sludge from Engineered Containers in the K East Basin to Engineered Containers in the K West Basin. This Change Order addresses Potential Issue 35 submitted in the Contractor's Statement of Material Difference (Deliverable C.2.1-2).

2. Definitizes Change Order number 36 by mutual agreement of the contracting parties in accordance with FAR 52.243-2, Changes - Cost Reimbursement and DEAR 970.5204-2, Laws, Regulations, and DOE Directives. The agreement results in a \$1,750,047 increase to the Continued ...
