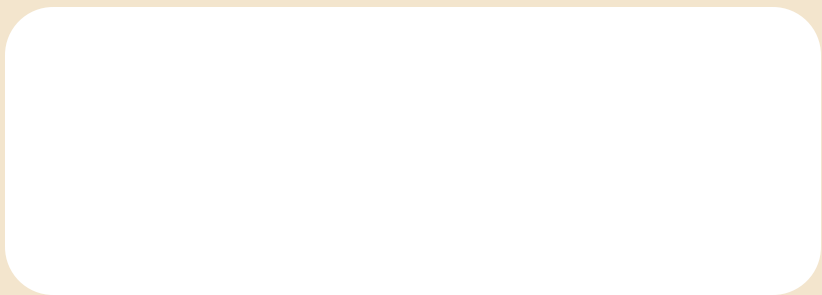
What Are Your Thoughts on Amnesty?

Illegal Immigration And Respecting The Rule Of Law

Rep. Calvert Record on Border Security and Illegal Immigration:

Created E-Verify – E-Verify is the only tool available for employers to check the legal status of newly hired employees. It is web-based, free to employers and 99.6% accurate. Rep. Calvert has a bill to make E-Verify mandatory for all employers in the U.S. which would end the job magnet that brings people here illegally (H.R. 19).

Secure Fence Act (P.L. 109-367) – Rep. Calvert worked with his colleagues to pass legislation to require physical fencing along the southern border.

H.R. 3308 – The SAVE Act. Fortifies border protection, requires mandatory employment verification, and increases interior enforcement.

H.R. 1868 – Citizenship Reform. Denies citizenship to an individual born in the U.S. if both parents are illegal immigrants or do not reside in the U.S. legally.

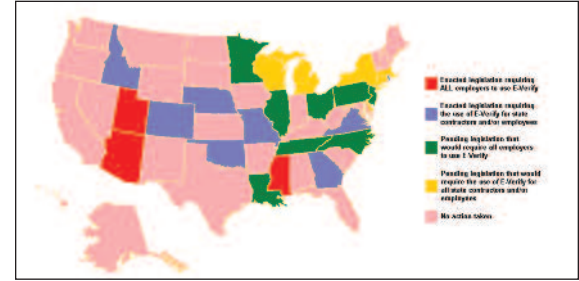
H.R. 2083 - Border Sovereignty and Protection Act. Provides for additional double-layer fencing along the southern border, combats drug and weapon trafficking, and makes E-Verify mandatory.

H.R. 997 – English Only. Declares English the official language of the United States.



REP. CALVERT tours the southern border and discusses issues with Border Patrol on how to gain operational control of our southern border to prevent illegal crossings, drug trafficking and violence.

E-Verify Continues to Expand
