WOLF: Turning to the gruesome claim by a group linked to al qaeda. It concerns iraq and the recent deaths of seven americans. Joining us now are military analyst retired u.S. Air force major don shepperd. Check out this video that some terrorist organization put out on the internet supposedly showing a u.S. Marine corps ch-46 c-stallion helicopter being shot down by insurgents. First of all, does it look credible to you?

SHEPPARD: Parts of it look credible. First of all, it is a ch-46 c-stallion helicopter. There the credibility ceases. You can't tell whether there is any gunfire involved there does not appear to be any missiles. The defense department says this may be mechanical malfunction. What we see first is a black plume coming out of the back of the airplane. Where the engines are. It could be an engine malfunction that started this crash. It could also be caused by ground fire we didn't see but you can't tell from this video.

WOLF: You certainly can't tell. Take a look at the vast expanse of iraq on our touch table. This is a huge area about the size of california. Six helicopters have gone down, u.S. Helicopters in the past three weeks alone. There is deep concern that perhaps the insurgents, the enemy, they've improved their capabilities to shoot down u.S. Helicopters. The investigations are continuing. You've studied this problem for a long time. What do you think?

SHEPPARD: I've spent a lot of time in helicopters both in iraq and in my career. I would be very cautious about drawing those conclusions.

Sometimes you lose arms. I lost three airplanes in five days once he so they gang up on you. The other thing is there is no similarity. The airplanes didn't go down in the same area and not the same time type and weren't doing the same thing. What tactics are we doing, what time of day are we flying and look at that to see if you need to alter anything but be careful about assuming these are due to increased enemy tactics or equipment.

WOLF: The blackhawk helicopters and army helicopters fly low to try to avoid the shoulder-fired missiles. At the same time they become more vulnerable to ground fire, if you will. And that is a problem. Why not fly at high altitudes it will be you avoid the ground fire and the threat of shoulder-fired missiles or stingers?

SHEPPARD: In the words of napoleon, the soldiers ride to the sound of gun. Where you have to provide them with fire support, if you will, that takes place down low and the helicopter has to be there and it's vulnerable. The more troops we put in there the more helicopter flights, the more helicopters we're going to lose. It's a fact of life.

WOLF: Unfortunate fact of life. General shepperd thank you for coming in.

Lt Col Rick Francona U.S. Air Force (Retired)

Lt Col Francona enlisted in the Air Force in 1970, and served as a Vietnamese linguist until 1973, conducting missions over Vietnam and Laos. After Arabic language training, he served at a variety of locations in the Middle East from 1975 to 1977, and supported the evacuation of the U.S. Embassy in Beirut, Lebanon in 1976. In 1978, he became an Arabic language instructor at the Defense Language Institute in Monterey, California.

Following his commissioning in 1979, Lt Col Francona was an instructor at the Air Force intelligence school in Denver, Colorado. From 1982 to 1984, he was a Middle East operations officer with the National Security Agency. In 1984, he was assigned as an advisor to the Royal Jordanian Air Force in Amman, Jordan.



In 1987, Lt Col Francona was assigned to the Defense Intelligence Agency as the assistant Defense Intelligence Officer for the Middle East. During this assignment, he spent much of 1987 and 1988 at the U.S. Embassy in Baghdad, Iraq, as a liaison officer to the Iraqi armed forces directorate of military intelligence. Lt Col Francona traveled extensively as an observer of Iraqi combat operations against Iranian forces, and flew sorties with the Iraqi air force.

Immediately following the Iraqi invasion of Kuwait in August, 1990 and through the Gulf War, Lt Col Francona was deployed to the Gulf as the advisor on Iraqi armed forces and personal interpreter to commander in chief of the U.S. Central Command, General Norman Schwarzkopf. As such, be was the lead interpreter for ceasefire talks with the Iraqi military at Safwan, Iraq, in March, 1991.

After the end of the Gulf War, the colonel served in the Office of the Secretary of Defense, and was a principal author of the Department of Defense report to Congress on the conduct of the Gulf war. In 1992, he was selected to be the first air attaché to the U.S. Embassy in Damascus, Syria, returning to the United States in early 1995. From 1995 to 1996, Lt Col Francona served with the Central Intelligence Agency, and participated in a variety of sensitive operations in the Middle East, including the escape of an Iraqi scientist's family. During one of these operations, he survived an attempt on his life by Iraqi intelligence service agents.

In 1996, the colonel was selected to develop the Department of Defense counterterrorism intelligence branch. In late 1997, the colonel led a special operations team supporting NATO forces in Bosnia. He returned to the United States and retired from active duty in 1998.

Since retiring from the Air Force, Lt Col Francona has written Ally to Adversary: An Eyewitness Account of Iraq's Fall from Grace, consulted with government and private firms, and become a media analyst on Middle East political-military events, currently under contract to NBC (seen on CNBC and MSNBC).

The colonel has a bachelors degree in government and the Arabic language, and a masters degree in international relations with a concentration in Middle East studies. His decorations include the Defense Distinguished Service Medal, the Bronze Star, and nine Air Medals, as well as campaign awards for service in Vietnam, the Persian Gulf, and the Balkans. The colonel was awarded the Central Intelligence Agency Seal Medallion for his service with that agency.

Lt Col Francona and his wife Emily reside in Port Orford, Oregon.

During the Iraq military campaign in 2003, Babbin subbed for North for nine weeks straight. Since then, Babbin has also subbed for Laura Ingraham, Hugh Hewitt and Greg Garrison, and now often serves as guest host on several shows for WMET AM 1160 Talk Radio in Washington, DC. He has traveled to the terrorist detention facility at Guantanamo Bay, Cuba.

Francis J. 'Bing' West

Francis J. 'Bing' West, originally from the Dorchester section of Boston, served as an infantry officer in the United States Marine Corps during the Vietnam War. A true warrior-scholar, West authored an extremely influential study while a Visiting Research Associate at the RAND Corporation 1966 - 1968 entitled: "The



Strike Teams: Tactical Performance and Strategic Potential". This paper was presented at the Annual DoD Counter Insurgency Research and Development Symposium, October 1968. The RAND Military Systems Simulations Group implemented a classified model of this Concept(s). This Doctrinal Innovation was directly opposed by MACV{Military Assistance Command Vietnam} in favor of the Army's Concept of Air-Mobility "Fire and Thunder Operations". Viz: Apocalypse Now.

He served as Assistant Secretary of Defense for International Security Affairs in the Reagan administration. He is a graduate of Georgetown University (BA) and Princeton University (MA), where he was a Woodrow Wilson Fellow. He is currently president of the GAMA Corporation, which designs wargames and combat decision-making simulations.

West is the author of several books relating to the United States Military. His collaboration with retired Marine MajGen "E-Tool" Smith, The March Up, was awarded the Marine Corps Heritage prize for nonfiction, as well as the Colby award for military nonfiction. Critics of The March Up, including some active duty Marines, argue that the book does not accurately portray events at several stages of the invasion, particularly the battle for Nasiriyah. This charge appears to stem from the book's quick composition. Tellingly, the book carries no source notes and it is frequently difficult to discern reported fact from opinion in the narrative.

Wayne Simmons

Recruited by the CIA in 1973 while in the U.S. Navy, Wayne Simmons became part of an outside paramilitary special operations group that was not only prepared to die for America, but they were prepared to go anywhere and do virtually anything when ordered. He spent his career in the Caribbean, Europe, the far east and central Asia working against, narco-terrorists, arms smugglers, counterfeiters, cyber-terrorists and industrial and economic espionage. He spearheaded deep cover intel ops against some of



the world's most dangerous drug cartels from central and south America and the middle east.

For 8 of his 27 years in the intelligence business, Wayne Simmons, ate slept and drank with narco-terrorists and smugglers while helping to conduct some of his nations most important anti-drug, intelligence gathering efforts on behalf of the central intelligence agency. His deep cover intelligence operations helped lead to the seizures of marijuana, cocaine and heroin with a combined value of over \$1 billion dollars.

Maj. Gen. Donald W. Shepperd, USAF (Ret.)

Major General Donald W. Shepperd, USAF (Ret.) is president of The Shepperd Group, Inc. He retired in 1998 from the Pentagon where he served as Director, Air National Guard. He commanded over 110,000 Air National Guard personnel, 1400 aircraft, 88 flying units, and 250 support units spread throughout the 54 states and territories. He oversaw preparation and execution of a \$4.2B yearly budget. He worked daily with all the Air Force Major Commands and congress. He testified to congress in support of Air National Guard and Air Force budgets. He served as part of the Air Force Council and was on the Board of Directors of the Air Force Long Range Strategic Plan. He was the architect of the highly successful "CyberGuard", a program to bring the Air National Guard into the world of high technology embedded information systems and fiberoptics with distributed communications and distance learning capabilities.

General Shepperd, grew up in Wheat Ridge, Colorado. After graduating from Wheat Ridge High School in 1958, he attended the United States Air Force Academy, graduating in 1962. He served on active duty as a fighter pilot in Europe and southeast Asia. He departed the service in 1969, after returning from the Vietnam War, where he flew 247 fighter combat missions. He became an airline pilot with Trans World Airlines and later the national sales manager of the light aircraft division of Grumman American Aviation Corporation in Cleveland, Ohio. He re-entered the Air Force in 1974 and retired in 1998 from the Pentagon as a Major General. Shepperd holds a Master of Science degree from Troy State University. He attended Seminar XXI, Massachusetts Institute of Technology and the Harvard University Program for Senior Executives in Government. He provides military commentary on request for ABC Radio Network in New York and serves as an ad hoc member of the Air Force Scientific Advisory Board. He started his own defense consulting firm and is also an associate with several Washington "think tanks." He is a well-known speaker on the subject of leadership and management for the 21^{st} century.

Major General Robert H. Scales, Jr., became the 44th Commandant of the U.S. Army War College in August 1997. Before moving to Carlisle Barracks, Pennsylvania, he was the Deputy Chief of Staff for Base Operations and the Deputy Chief of Staff for Doctrine at the Training and Doctrine Command Headquarters, Fort Monroe, Virginia. He is a 1966 graduate from the United States Military Academy and he later received a Masters and Ph.D. in history from Duke University. Commissioned as a field artillery officer, General Scales served in numerous command and staff positions throughout the Army. His commands include four artillery batteries, two in Germany and two in Vietnam; an artillery battalion in Korea and the U.S. Army Field Artillery Training Center, Fort Sill, Oklahoma. He also served as the Assistant Division Commander. 2d Infantry Division. Eighth U.S. Army. His decorations include the Distinguished Service Medal, Silver Star, Legion of Merit with four Oak Leaf Clusters, the Bronze Star Medal, Meritorious Service Medal with four Oak Leaf Clusters and the Air Medal. He wears the Senior Parachutist Badge, the Army Staff Badge and the Ranger Tab. General Scales is the principal author of Certain Victory, the 1993 official Army account of the Gulf War. His latest book, Firepower in Limited War, is a 1994 publication that outlines the history of fire support in post-World War II conflicts. During the past four years, General Scales has published numerous articles within several European and American defense journals. In November 2000 he retired from active duty.

MAJOR F. ANDY MESSING JR.

USAR, (Ret.), U.S. Army Special Forces
Executive Director
National Defense Council Foundation

Major F. Andy Messing Jr. has been the Executive Director of the National Defense Council Foundation (NDCF), which studies and publishes on Special Operations/Low Intensity Conflict (SOLIC) matters, since 1984. As a sidebar, to get into hostile areas, NDCF does refugee relief operations for humanitarian and academic purposes. Accordingly, Messing has personally supervised the distribution of more than 140.5 tons of food, but mainly medicine, into combat areas of Latin America, the Philippines and Africa. He has led over 100 key opinion makers, including Members of Congress, the media, and other VIP's into 26 conflict areas worldwide. Before running NDCF, he ran/consulted w/ three other high profile political, defense & foreign affairs groups, and had worked Congressional Affairs for the Department of Defense (DOD) as a GS-13 at age 29. In 1980 Messing organized Vietnam Veterans for Reagan, in 1986-88 he consulted directly with Mr. Lee Atwater and George Bush, "Jr." in the Bush for President campaign. He has worked on Capitol Hill for the former Congressman Robert K. Dornan & for Congressman Dan Burton, both in regard to Defense issues. Additionally, he advised President Fidel Ramos's campaign in the Philippines (1992). Furthermore, he was a Consultant for DOD (1987) on Central American matters and again for the State Department from April of 1990 to May of 1993 in regard to the Philippines and Russian/NIS matters. Messing has taught/lectured at the U.S. Army Transportation School, U.S. Infantry School, the Central Intelligence Agency, Inter-American Defense Board, Industrial College of the Armed Forces, and various universities across the country, to include the U.S. Naval Academy, West Point, and the U.S. Coast Guard Academy.

Messing has an extensive background in defense and foreign affairs. He attended William & Mary while in the Army, completing his education at the University of Maryland, College Park, where he earned a Bachelor's Degree in Education with a minor in Political Science. He also attended numerous military schools having received his Commission at age 20 at Ft. Benning, GA. Messing served as an Infantry Platoon Leader, 1st Air Cavalry Division, in Vietnam 1967. He received military service awards, including two Purple Hearts, and the Meritorious Service Medal. He earned German, Canadian, and Senior American parachute wings with 71 military jumps. Messing, who had a total of 9 years active service, retired a Major from the Reserves in 1987. Later, he became a military consultant specifically for MSNBC Hardball continuing through 2002.

Additionally, Major Messing has two children, LT Camilla B. Messing USCG, a 1997 U.S. Coast Guard Academy graduate, currently the Skipper of the 110 foot Cutter, the KISKA in Hilo Hawaii and LT Frederick A. Messing III, USNR, a 1997 U.S. Naval Academy graduate & U.of Penn. Masters graduate in Computer Science, who is assigned to a Reserve Intel unit in Norfolk, VA. Major Messing lives on a 41 Foot Sailboat the ARK ANGEL in Key West Florida.

He retired from military service as Assistant Vice Chief of Staff of the Air Force and Director of the Defense Performance Review, reporting to the Secretary of Defense. He led the Pentagon's "reinventing government" effort, visiting more than 100 leading-edge commercial companies to assimilate their ideas about business re-engineering.

General McInerney graduated from the United States Military Academy and earned a Master's degree in international relations from George Washington University. He also attended the Armed Forces Staff College and National War College.

In January 2000, Lieutenant General Thomas McInerney, USAF (Ret.), established his own consulting firm, GRTT (Government Reform Through Technology). From March 1996, to December 1999, he was Chief Executive Officer and President of Business Executives for National Security (BENS), a national, nonpartisan organization of business and professional leaders, with headquarters in

Washington, DC. BENS works to engage the business community in securing America's future with a more efficient defense establishment. In February 2000, General McInerney received a <u>Laurel</u> from *Aviation Week and Space Technology* magazine for his efforts on behalf of military reform as President of BENS. He has also made numerous appearances on National Television discussing Defense Reform and during global military crises such as Kosovo, EP 3 incident in China and now the War on Terrorism where he is the senior Fox News Military Analysts.

Prior to joining BENS, General McInerney was Vice President of Command and Control for Loral Defense Systems-Eagan. He joined Loral (then Unisys Electronic Systems Division) in 1994 following 35 years as a pilot, commander, and Joint Force Commander in the United States Air Force.

General McInerney retired from military service as Assistant Vice Chief of Staff of the Air Force and as Director of the Defense Performance Review (DPR), reporting to the Secretary of Defense. Dr. Jeff McCausland is Director of the Leadership in Conflict Initiative at Dickinson College. As a Senior Fellow, He leads the Carnegie Council's work on one of its three theme areas, Ethics, War, and Peace.

Major General David L. Grange Biography

Major General David L. Grange was born in Lake Ronkonkoma, New York. After receiving his commission from North Georgia College in December 1969, he was assigned to duty as the reconnaissance platoon leader with the 2nd Battalion, 505th Infantry Regiment, 82nd Airborne Division.

In 1970, he volunteered for Vietnam and served as a rifle platoon leader with the 101st Airborne Division and later as reconnaissance platoon leader in L Company, 75th Rangers. During a second tour in Vietnam, he served as a reconnaissance advisor to the 81st Airborne Ranger Group. He returned to Fort Bragg, North Carolina in 1972 as executive officer and then commander of HALO and Scuba Detachments in the 3rd Battalion, 5th Special Forces Group.

After flight school in 1974, Grange was assigned to the 101st Airborne Division at Fort Campbell, Kentucky, where he served as Flight Platoon Commander in the 158th Aviation Battalion. Later, he commanded a rifle company in 2/503 Infantry and then served as Current Operations Officer in Division G3.

After the Infantry Advanced Course in June 1978, Grange served as the 1st Ranger Battalion Adjutant, Charlie Company Commander, and Battalion Special Operations Liaison Officer in the 75th Infantry, Rangers.

After the British SAS course in 1981, he studied at the USMC CGSC and then served as Squadron Commander and the Operations Officer for 1st SFOD.

Grange volunteered for service in Korea and commanded the 1st Battalian, 503rd Infantry, 2nd Infantry Division from 1987-1989. He returned to the U.S. and served as a Special Operations Officer with the SOCOM Washington, D.C. office enroute to the National War College. Upon completion of the war college, he reported to Fort Bragg as the Deputy Commander of the 1st SFOD, where he commanded a Task Force during DESERT STORM. From 1991-1993, he commanded 75th Ranger Regiment.

In Aug. 1993, Grange was reassigned to Fort Bragg, North Carolina where he served as DCO, Army Special Operations Command. In 1994, he deployed to Germany as ADC, for Support and then Maneuver, of the 3rd Infantry Division. After service with 3ID, Grange was assigned in 1995 to the Pentagon as Deputy Director, and then as Director, for Army Operations,

Readiness and Mobilization. In this capacity, he was also the Director of Military Support (DOMS) responsible for military support throughout the United States for national disasters and consequence management of terrorist attacks.

In July 1997, Grange redeployed to Germany and took command of the Big Red One and Task Force Eagle in Bosnia. During his command, Grange was responsible for U.S. forces and operations in Macedonia and Kosovo. MG Grange retired from military service in Jan. 2000.

Military qualifications include the CIB, EIB, Special Forces Tab, Ranger Tab, Army Aviation Wings, Master HALO Wings, Master Parachutist Wings, Air Assault Wings, Pathfinder Badge, Scuba Badge, and SAS Badge. Awards include: 2 DSM, 3 SS, 2 DSSM, 3 LOM, 2 BS, and 2 PH.

He is married to the former Holly Getz and they have two sons, David and Matthew.

Lieutenant Colonel Robert Maginnis United States Army, Retired

Lieutenant Colonel Robert (Bob) Maginnis, US Army (retired) is an experienced and internationally known expert on national security and foreign affairs. He currently serves as a national security and foreign affairs analyst for Moody Broadcasting Radio Network, Salem Radio Network, and is a regular guest on several other radio networks. He recently completed a year as a



Fox News military analyst. He is a senior systems analyst with BCP International Limited, an Alexandria, VA-based company where his primary duties involve working on multinational programs for the Department of the Army. Since October of 2002, Colonel Maginnis has been a member of Secretary Donald Rumsfeld's Military Analyst Group.

Before coming to BCP International Colonel Maginnis served as the vice president for policy with the Washington, DC-based Family Research Council. While with FRC, Colonel Maginnis supervised a staff of policy experts and also served as the organization's expert for national security, foreign affairs, crime prevent and drug policies. He has testified numerous times before Congressional committees.

In his many roles, Colonel Maginnis has appeared on ABC, NBC and CBS evening news shows, CBS 60 Minutes, CBS This Morning, ABC Good Morning America, PBS Newshour with Jim Lehrer, MSNBC Equal Time, Hardball, Internight, and The News with Brian Williams, Court TV's Pro and Con, Fox News The O'Reilly Factor, Hannity and Colmes, and is a regular guest on On the Record, CNN's Crossfire, Larry King Live, Talk Back Live, Wolf Blitzer Reports, Late Edition as well as other programs, such as Donahue and The Jenny Jones Show. He has been quoted many times in newspapers and magazines across the world such as The New York Times. US News & World Report and Time Mazazine. Since 1993, he has written more than 500 articles, many of which have been published in distinguished newspapers and magazines nationwide. Colonel Maginnis has testified before congressional committees on military personnel issues, drug policy, AIDS, teen violence and homosexuality. His policy papers have been entered into the Congressional Record and his material is frequently used by members during floor debates. He is also a respected anti-drug expert having spoken at conferences in the United States and abroad. His anti-drug insights are sought by the media, grassroots activists, and government officials.

In July 1993, Colonel Maginnis retired from an assignment in the Pentagon where he served as an Inspector General. He is an airborne-ranger infantry officer with an assignment history that includes Korea, Germany, Alaska, and several posts in the continental United States. He served in command and staff positions in four infantry divisions from platoon to division level. The colonel was the chief for the U.S. Army Infantry School's leadership and ethics training branch. He developed curricula, taught, participated in leader development research and consulted with leaders and soldiers throughout the Army. He is the author of more than fifty articles published in professional military journals concerning ethics, leadership, and personnel matters impacting the military. Colonel Maginnis' service in the armed forces was commended with the Legion of Merit, one of the highest Army peacetime decorations, as well as with five meritorious medals and four commendation medals.

In the last eight months of his military service, Colonel Maginnis was a member of the Army's study group examining the homosexual ban. He also was advisor to the Defense Department Military Working Group on homosexuals in the military. In that role, he debated the issue in the media as well as speaking in various forums - including testifying before a House subcommittee.

Colonel Maginnis received his B.S. from the United States Military Academy, West Point, New York in 1973 and a M.S. from the Naval Postgraduate School, California, in 1983. He is a graduate of many military schools, including the Command and General Staff College and the US Army's War College strategy course.

Colonel Maginnis was born on October 3, 1950, in Orlando, Florida, and was raised in Alabama, California and Tennessee. He and his wife Jan have two children, Meghan, a recent graduate of Liberty University and now an employee with Booz-Allen-Hamilton in McLean, Virginia and Grant, a senior at Evangel Christian School, Dale City. They have made their home in Woodbridge, Virginia since 1990. They are active members at Calvary Baptist Church in Woodbridge.

General Jack Keane United States Army, Retired

General Jack Keane served 37 years in the Army, rising to the rank of four-star General. Most recently, he held the position of the Vice Chief of Staff of the Army. During his four years in this job as Chief Operating Officer of the United States Army, he managed operations of more than 1.5 million soldiers and civilians in over 120 countries and an annual budget in excess of \$110 billion dollars. Throughout his tenure in this position the Army has fought and won wars in Afghanistan and Iraq, while supporting numerous worldwide peace operation, maintaining readiness, and transforming to a faster, more deployable force.



As the Vice Chief of Staff, General Keane developed and maintained strong relationships, on behalf of the Army, with Congress, the media, opinion leaders, national security policy makers, and the American people. In doing so, he delivered over 400 speeches in four years, communicating critical Department of Defense and Army messages. He testified before Congress on 18 separate occasions on subjects as diverse as the war in Iraq, Military Health Care, the Budget, Environmental Law, Army Readiness and Army transformation.

General Keane was a career paratrooper who commanded at every level to include the 18th Airborne Corps and Fort Bragg, NC; the 101th Airborne Division (Air Assault) and Fort Campbell, KY; and the Joint Readiness Training Center. He also served as the Deputy Commander-in-Chief of the United States Atlantic Command prior to becoming the Army's Vice Chief of Staff, and was featured in Tom Clancy's book, AIRBORNE.

General Keane is a combat veteran having served as a platoon leader and company commander in Viet Nam. His units deployed to Somalia, Haiti, Bosnia and Kosovo.

General Keane graduated from Fordham University business school in 1966 with a Bachelor of Science Degree in Accounting and holds a Masters of Arts Degree in Philosophy from Western Kentucky University. His military education includes the Infantry Officers Basic and Advanced Courses, the United States Army Command and General Staff College, and the United States Army War College. General Keane is the recipient of an honorary PH.D in Law from Fordham University and an honorary PH.D in Public Service from Eastern Kentucky University.

General Keane's Army awards and decorations include: two Defense Distinguished Service Medals, two Army Distinguished Service Medals, the Silver Star, five Legions of Merit, the Bronze Star Medal, the Ranger Tab, the Combat Infantryman's Badge, the Master Parachutist Badge, and the Air Assault Badge.

Since his retirement from the Army, General Keane is currently President GSI, LLC, is senior advisor to Kohlberg, Kravis, Roberts and Co. and advisor to Chairman and CEO, URS Corporation. He is a director of METLIFE, Inc and General Dynamics Corporation.

General Keane serves as a member of the Department of Defense Policy Board. He is also a military contributor and analyst for ABC News.

General Keane is married to the former Theresa W. Doyle. They have two adult children, Matthew and Daniel.

Colonel Jack Jacobs United States Army, Retired

Colonel Jack Jacobs, who entered military service through Rutgers ROTC, earned the Medal of Honor for exceptional heroism on the battlefields of Vietnam. He also holds three Bronze Stars and two Silver Stars.



Jacobs was an adviser to a Vietnamese infantry battalion when it came under a devastating fire that disabled the commander. Although bleeding from severe head wounds, then-First Lieutenant Jacobs took command, withdrew the unit to safety, and returned again and again under intense fire to rescue the wounded and perform life-saving first aid. He saved the lives of a U.S. adviser and 13 allied soldiers.

Jacobs served on the faculty of the U.S. Military Academy at West Point and the National War College in Washington, D.C. After retirement, he founded and was chief operating officer of Auto Finance Group. As a managing director of Bankers Trust Co., he led Global Investment Management to \$2.2 billion in assets and later co-founded a similar business for Lehman Brothers. He is a member of the Council on Foreign Relations and is a director of the Medal of Honor Foundation. He is also a military analyst for NBC/MSNBC.



Steve Greer retired from the United States Army after serving 20 years as an Airborne Ranger and Green Beret. Recruited by Fox News Channel, his on-air "War Room" analysis helped shape public opinion as the coalition invaded Iraq in early 2003.

An expert in Soldiering, his commentary continues to raise awareness of the challenges facing American troops in the war on terrorism. With more than 400 interviews on FOX, CNN, NBC,

and National Public Radio, Greer's insight and passion for serving a nation at war is heard around the world.

Greer is the sole enlisted member of the Office of the Secretary of Defense analyst group. Through unprecedented access to senior government officials his insight is fresh and powerful. As a senior fellow at the National Defense Council Foundation he has met with senior government officials in Haiti, Israel, Kosovo, Morocco, Iraq, Kuwait, Cuba and the United States conducting research on the War on Terror.

He is a four-time competitor in the grueling Lieutenant General David E. Grange, Jr., Best Ranger Competition and the only Sergeant Major in the world to compete. At 33 years of age he was selected as one of the youngest Sergeants Major in the Army. He speaks at and supports special venues throughout the country carrying the voice of free Americans to those who need to hear it most.

Military Officers Criticize Media Coverage Of Battlefront In Iraq SAN DIEGO -- Officers discussing the Iraq war last week criticized media coverage of the battlefront, arguing that the press has ignored some U.S. successes in the country.

The officers made the comments during a panel session here at the West 2007 naval conference

Brig. Gen. Michael Callan, commander of Air Force special operations forces and director of operations for Air Force Special Operations Command, said he is concerned the media is too one-sided in Iraq coverage.

"As an American, I'm a little concerned . . . with regard to the media only telling one side of the story," he said.

He noted that Iraq "is learning to stand" on its own, "and the media needs to tell that side of the story, and to date they really haven't done a good job of it."

Similar comments were made by Col. Michael Shupp, chief of staff of the Pentagon's Joint Improvised Explosive Device Defeat Organization, who served as regimental commanding officer for the 1st Marine Division in Iraq from 2004 to 2005. Shupp said the media was ignoring the progress made by Iraqi security forces since the United States began training in the country. Also, Shupp said the press discounts accounts of bravery of the Iraqi troops, such as their willingness to assist Marines in the streets and to enter a dangerous building before Marines.

Cmdr. Steven Wisotzki, chief of staff for Naval Special Warfare Group One, said many stories do not appear in the press, such as the status of security in al Anbar province.

"Al Ambar is improving. You don't see it much in the news, and I wish we could get the . . effort energized to show the American public what is happening," he said.

Wisotzki said some items that have not appeared in the press include special operations' success in foreign internal defense. This effort spans the spectrum of tribal engagement and involves working closely with government leaders, he said. Efforts to secure Ramadi have not been widely reported, he added. Wisotzki said the security has improved considerably since the expulsion of al Qaeda from the city.

Retired Army Major Gen. David Grange, president of the McCormick Tribune Foundation, a charity that focuses on journalism, said producers decide which Iraq news stories run on television and are more eager to report stories that involve bloodshed.

"Quite often what's put on television is made by producers," he said. "Just like

newspapers, some are biased one way or the other."

Grange's remarks prompted audience member Bob Timberg, editor-in-chief of the U.S. Naval Institute's Proceedings magazine, to respond angrily that Grange was unfairly characterizing the media. The conference was cosponsored by the institute and the Armed Forces Communications and Electronics Association.

Timberg noted that many journalists had been killed in Iraq covering the war and that painting a media conspiracy was unreasonable.

"I frankly find it incredible that you would sit up there and speak to this audience and [say] this old saw about the producers," he said.

Grange apologized to Timberg. However, Grange maintained his position that the media did not report some stories.

"I've . . . seen some stories not run because people just didn't want that story on the air," he said.

Despite these complaints, some officers said media coverage benefited operations. Journalists embedded with his Marines during the battle of Fallujah did "good reporting," Shupp said.

"I think part of it too was that the media know that if they didn't stay by us, they would be the next one on the video," he said, referring to gruesome insurgent videos of hostage slayings.

Shupp said while journalists embedded with the military provide good coverage, some news stories go through "editing chains" and are not produced.

He also suggested that the media should not just come and go to cover battles in Iraq but also report on successes that occur over the duration of activity in the country, he said. Additionally, Shupp said the military needs to do more to tell the media of its success.

Army Lt. Col. John Nagl, commanding officer of the 1st Battalion of the 34th Armor at Ft. Riley, KS, had good words to say about the press covering the battlefront.

"In my previous experience with some very, very brave journalists who really hung it out on the line, I have nothing but respect for these guys," he said.

Wisotzki said the focus should not be so much on influencing U.S. media coverage but changing Arab media coverage because "the people we're trying to influence are the people in the Arab world." The United States should make a greater effort to work with Arab media outlets, including al Jazeera, he said.

Feb. 2 (Bloomberg) -- President George W. Bush's record request for defense funding for 2008 may set up a fight with the Democratic Congress, keen to examine the budget for questionable spending.

Bush will request \$716 billion for defense and the global war on terror when he submits his fiscal 2008 budget next week, according to a Pentagon document. The military funding request is greater than the annual gross domestic product of all but 14 countries.

The request to Congress includes \$93.4 billion in additional money for fiscal 2007 to cover costs of the fighting in Iraq and Afghanistan. The remaining \$622.6 billion would cover the year ending Sept. 30, 2008 and include \$141.7 billion for the wars.

Congress has already promised increased scrutiny of the additional funding request for 2007, wary that it will include items that should be funded in the annual budget, such as \$389 million requested to buy two Lockheed Martin Corp. Joint Strike Fighters that won't be operational until 2012 to replace F-16 fighters lost in Iraq.

There's been `less justification' for the funding than there should be, House Budget Committee Chairman John Spratt of South Carolina said in an Jan. 30 interview. Spratt said he and other lawmakers are concerned that the requests contained items not of an "emergency"

Increasing the Force

Bush proposes to add \$7.7 billion over this year's budget to increase the Army by 65,000 troops and add \$4.4 billion to increase the Marine Corps by 27,000 people by 2012. The budget also would add \$700 million to increase U.S. special operations forces by 5.575 on the way to a total force of 54,367 Army, Air Force and Navy commandos, an overall increase of almost 10,000 since fiscal 2005, according to the document.

The budget provides the resources needed to organize, man, train and equip our military forces, '' said the two-page summary prepared by the Pentagon comptroller. "The budget provides increases to substantially increase Army and Marine Corps capability and improve overall readiness, " the summary said.

Fiscal 2007 defense spending will total about \$622 billion if Congress approves the

second half of the emergency wartime funding requested next week.

That is more than we have spent, in real, inflation- adjusted dollars, in any year since the height of the Korean war and about \$140 billion more in today's dollars than we spent at the height of the Vietnam War,'' Steven Kosiak, a defense analyst with the Center for Strategic and Budgetary Assessment in Washington, said in an e-mailed statement.

Ten Years of Growth

The fiscal 2008 request will represent the 10th consecutive year of growth in the defense budget after a post-Cold War low point in 1998.

The basic peacetime budget for fiscal 2008 is \$481.4 billion, or about 10.6 percent more than Congress approved for this year. It includes \$101.7 billion for weapons and \$75.1 billion for research and development.

The cost of the wars in fiscal 2007 would rise to \$163.4 billion, \$45.4 billion more than was approved in fiscal 2006 for wartime spending, if Congress approves the additional \$93.4 billion. That figure is about \$6.3 billion less than the \$99.7 billion that the Pentagon estimated in December that it would need.

Previous emergency wartime requests have been readily approved because Congress was eager to support U.S. troops at war. Deputy Defense Secretary Gordon England got lawmakers'

attention in October with a memo encouraging service chiefs to include in the new request any items related to the `global war on terror,'' not strictly Iraq and Afghanistan.

Congress in the law authorizing defense spending this year required that the Pentagon, starting with fiscal 2008, break out the war funding request in its annual budget proposal.

Army's Request

Bush is asking \$128.6 billion in fiscal 2008 to begin the Army's effort to increase its current authorized force of 482,000 by 65,000 troops, including personnel expenses, and equipment, according to Pentagon documents to be released along with the budget Feb.

The cost of the Iraq and Afghanistan conflicts, as well as the billions of dollars needed to repair and replace equipment, is being paid from the emergency war funding.

The Army wants \$46.2 billion for personnel expenses, up from \$42.6 billion this year. The number would jump to \$51.3 billion in fiscal 2009. The request provides for a 3 percent across-the-service pay increase in fiscal 2008, increasing to 3.4 percent in 2009, the document said.

Machine Guns, Radios

Money to buy vehicles, machine guns, ammunition, radios and other gear increases to \$23.8 billion from \$16.8 billion this year to accommodate a larger Army. This account would increase to

\$26.2 billion in fiscal 2009. That's nearly a 145 percent increase from fiscal 2002, according to the documents.

The Army's military construction budget would grow to \$4.6 billion in fiscal 2008 from \$2.7 billion this year.

The budget requests \$37.7 billion to pay for training, unit deployments and weapons-systems maintenance -- up from \$32 billion this year. That amount would increase to \$40.4 billion in fiscal 2009. Army officials have said the overall increase in this category will cost about \$70 billion through 2012, \$18 billion of that for equipment.
