ENERGY AND WATER DEVELOPMENT PROGRAMMATIC HIGHLIGHTS:

- A \$36 million increase for Idaho National Laboratory facilities over the President's request. Total Idaho Facilities Management funding is targeted at \$140 million. The additional funding is available for a variety of uses including new buildings, renovation of existing buildings, and equipment purchases, and the Advanced Test Reactor's operation as a National Scientific User Facility.
- A \$110 million increase for the Generation IV Nuclear Energy Systems program bringing total funding to \$180 million. \$169 million of this funding is targeted to the Next Generation Nuclear Plant which will be built at INL.
- A \$43.6 million increase over the President's request for cleanup activities at INL bringing total cleanup funding to \$475,761,000.
- \$13.478 million for Non-Defense cleanup activities at INL for the remediation of contaminated facilities – an increase of \$9.1 million over the President's request.
- \$145 million for the Advanced Fuel Cycle Initiative.
- \$14.334 million for the National Spent Nuclear Fuel Program at INL
