




- In 2002, there were over 27,100 minority firms in Connecticut generating more than \$4 billion in gross receipts.
- These firms also employed between 25,000 and 49,999 workers.
- Minority firms represented 9.3% of all 'classifiable' firms located in the state.
- The number of minority firms in Connecticut increased by 33% between 1997 and 2002, compared to 6% for all 'classifiable' firms in the state.
- Connecticut had the 28th largest minority population, numbering about 801,660 or 23.2% of the state's total population in 2002.


Percentage of Minority Population, Number of Firms and Gross Receipts Compared to Classifiable Firms, Connecticut – 2002



- In Connecticut, Native Hawaiian and Other Pacific Islanders reached parity in number of firms and total gross receipts when compared to their representation in the state's population. No other of the minority groups reached parity.
- If minority business activity in Connecticut matched the state's minority population percentage in 2002, the number of minority firms in the state would have exceeded 67,600 and they would have generated nearly \$30.2 billion in gross receipts and employed more than 153,700 workers.

Minority Firms in Connecticut by Gross Receipts Size, 2002



- While smaller in number, minority-owned with receipts of \$500,000 or more generate a much larger percentage of all the group's revenues and paid employment than firms with receipts under \$500,000.
- In 2002, minority-owned firms with receipts of \$500,000 or more generated about 68% of all receipts grossed by all minority firms in Connecticut and employed 68% of all paid workers employed by minority firms in that state.
- Minority-owned firms in Connecticut were also more concentrated in the following industries: health care and social assistance; other services; professional, scientific, and technical services; and retail trade.
