


The State of Minority Business: Delaware



- In 2002, there were over 7,100 minority firms.
- These firms also employed between 5,000 and 9,999 workers.
- Minority firms represented 12% of all 'classifiable' firms located in the state.
- The number of minority firms in Delaware increased by 34% between 1997 and 2002, compared to 13% for all 'classifiable' firms in the state.
- Delaware had the 40th largest minority population in the country, numbering more than 225,000 or 27.9% of the state's total population in 2002.

Percentage of Minority Population, Number of Firms and Gross Receipts Compared to Classifiable Firms, Delaware – 2002




- In 2002, only Asian Americans reached parity in their number of firms and total gross receipts. No other minority group reached parity.
- If minority business activity in Delaware matched the state's minority population percentage in 2002, the number of minority firms in the state would have exceeded 16,500. They would have generated \$4.75 billion in gross receipts and employed 45,000 workers.

Population estimates for 2002 were for all ages.

Minority Firms in Delaware by Gross Receipts Size, 2002



- While smaller in number, minority-owned Strategic Growth Initiative (SGI) firms, which have annual receipts of \$500,000 or more, generate a much larger percentage of all the group's revenues and paid employment than firms with receipts under \$500,000.
- In 2002, SGI firms generated about 68% of all receipts grossed by all minority firms in Delaware and employed 64% of all paid workers employed by minority firms in that state.
- Minority-owned firms in Delaware were also more concentrated in the following industries: health care and social assistance; other services; retail trade; and professional, scientific, and technical services.

S = Estimates are suppressed when publication standards are not met. Total percentages for minority firms by industry may exceed 100% because some firms may be classified in more than one industry.
