




Change in Number of Firms and Gross Receipts for Firms in Illinois 1997 - 2002

- In 2002, there were over 153,000 minority firms in Illinois, of which about 16% (24,057) were employer firms.
- Minority firms represented 16.4% of all 'classifiable' firms located in the state.
- The number of minority firms in Illinois increased by 39% between 1997 and 2002, compared to 8% for all 'classifiable' firms in the state.
- Illinois had the fifth largest minority population in the country, numbering about 4.2 million or 33% of the state's total population in 2002.


Percentage of Minority Population, Number of Firms and Gross Receipts Compared to Classifiable Firms, Illinois – 2002



- In Illinois, only Asian Americans, and Native Hawaiians and Other Pacific Islanders have reached parity in their number of firms when compared to their representation in the state's population. No minority group has reached parity in gross receipts.
- If minority business activity in Illinois matched the state's minority population percentage in 2002, the number of minority firms in the state would have exceeded 308,000 and they would have generated over \$141 billion in gross receipts and employed about 840,000 workers.

Minority Firms in Illinois by Gross Receipts Size, 2002



- While smaller in number, Strategic Growth Initiative (SGI) minority-owned firms, which have annual receipts of \$500,000 or more, generate a much larger percentage of all the group's revenues and paid employment than firms with receipts under \$500,000.
- In 2002, minority-owned firms with receipts of \$500,000 or more generated about 78% of all receipts grossed by all minority firms in Illinois and employed 73% of all paid workers employed by minority firms in that state.
- Minority-owned firms in Illinois were also more concentrated in the following industries: health care and social assistance; other services; and professional, scientific, and technical services.
