




Change in Number of Firms and Gross Receipts for Firms in North Carolina 1997 - 2002

- In 2002, there were almost 80,000 minority firms in North Carolina generating about \$9.4 billion in gross receipts, and employing overt 87,000 workers
- The number of minority firms in North Carolina increased by 29% between 1997 and 2002, compared to 12% for all 'classifiable' firms in the state.
- Minority firms represented 12.6% of all 'classifiable' firms located in the state.
- North Carolina had the 8th largest minority population, numbering about 2.5 million or 30.6 % of the state's total


Percentage of Minority Population, Number of Firms and Gross Receipts Compared to Classifiable Firms, North Carolina – 2002



- In North Carolina, only Asian Americans have reached parity in their number of firms when compared to their share of the state's population. No other minority group has reached parity in their number of firms or gross receipts.
- If minority business activity in North Carolina matched the state's minority population percentage in 2002, minority firms in the state would have exceeded 191,000 in number, generated over \$70.7 billion in gross receipts and employed more than 482,000 workers.

These are firms whose ownership can be classified by race, gender of Hispanic origin. Total numbers for Classifiable Firms represent MBDA estimates. Minority Firms in North Carolina, by Gross Receipts - 2002



- While smaller in number, Strategic Growth Initiative (SGI) minority-owned firms, which have annual gross receipts of \$500,000 or more, generate a much larger percentage of the group's revenues and paid employment than firms with receipts under \$500,000.
- In 2002, minority-owned firms with receipts of \$500,000 or more generated about 69% of all receipts grossed by all minority firms in North Carolina and employed 68% of all paid workers employed by minority firms in that state.
- Minority-owned firms in North Carolina were also more concentrated in the following industries: other services; health care and social assistance; and retail trade.
