

Population by Race (Race Alone and in Combination) - Puerto Rico, 2007

- In 2007, there were 3.9 million people in Puerto Rico, of which 3.8 million (96%)were Puerto Ricans.
- Hispanics, including Puerto Ricans, may be of any race.
- About 80% of the population of Puerto Rico was White, and 11% was Black or African American.



□ White, 3,168,698 people (80.4%)



- In 2000, 97,452 individuals in Puerto Rico (10.5% of the working population 16 years old and over) identified themselves as self-employed.
- Among those who were 16 years and older, 3.4% were self-employed in 2000.

Establishments for Firms with Payroll in Puerto Rico by Gross Receipts Size, 2002



- Establishments with receipts of \$500,000 or more represented 37% of the total establishments in Puerto Rico, generated 94% of gross receipts and employed 85% of paid workers in 2002.
- Establishments are for firms with payroll, regardless of ownership, including publicly held firms. A firm may consist of one or more establishment.
- The chart does not include data on establishments in construction; manufacturing; and forestry, fishing and hunting, or agricultural support services.
- Industry sectors with the highest concentration of establishments include retail trade (25.9%); health care and social assistance (14.6%); and accommodation and food services (9.3%).
