TRICARE Reserve Select

(TRS) is a premium based health insurance plan that is available to all drilling members of the Guard or Reserve.

Who qualifies?

- Members of the National Guard or Reserves who are actively drilling and their Family Members.
- Must Not be eligible for Federal Employees Health Benefits, (FEHB).

Who does NOT qualify for TRS?

- Anyone who qualifies for FEHB
- Discharged soldiers
- IRR soldiers

How much is it? (Rates as of 1 January 2010)

Soldier only = \$49.62 per month Soldier and family = \$197.65 per month

What else do I need to know?

- If you are placed on Active Duty (Title 10, Title 32, ADSW), you will have to re-enroll within 60 days of the expiration of orders for continued coverage.
- If you or a family member are dis-enrolled from TRS for any reason other than active duty orders, you will be locked out of TRS for one year. You may request reinstatement to the TRS program if you are locked out: http://www.humana-military.com/library/pdf/trs-reinstatement-request-form.pdf
