Atlantic Commercial Shark Fishery Update

Below are landings estimates in metric tons (mt) dressed weight (dw) for the Atlantic shark fisheries for the 1st season of 2004 (January through June). These landings estimates include landing reports received as of February 27, 2004. Any state landings and over/underharvests from this season will be totaled and counted against future quotas, as appropriate. Additionally, any unclassified landings are considered, at this time, to be large coastal sharks.

Based on preliminary landings reports, it appears the small coastal shark fishery in the Gulf of Mexico region has exceeded the quota for the 1st season. Accordingly, NOAA Fisheries will be issuing a closure notice for the commercial small coastal shark fishery in the Gulf of Mexico. The closure notice announcing a closure date will be published in the Federal Register shortly.
