DSCA Policy 10-46, [SAMM E-Change 165]

This memorandum updates SAMM Chapter 10, Table C10.T3., to reflect the list of schools/courses that encourage IMS to bring dependents. Schools that provide pre-requisite training or follow-on training are deleted as they no longer encourage bringing dependents. As this change has already taken place, it is effective immediately.

Note (7), Additional Information for Table C10.T3., is revised to read as follows:

<b>Additional Information for Table C10.T3.</b>
<p>(7) The International Military Student is encouraged by the Department of Defense to bring dependents ONLY to the following:</p> <ul style="list-style-type: none"><li>– Air Command and Staff College</li><li>– Army Sergeants Major Course</li><li>– Air War College</li><li>– Army War College</li><li>– Graduate Programs at Naval Postgraduate School</li><li>– Graduate Programs at the Air Force Institute of Technology</li><li>– Inter-American Defense College</li><li>– Intermediate Level Education (ILE) and School of Advanced Military Studies at the Army Command and General Staff College; and ILE at the Western Hemisphere Institute for Security Cooperation (WHINSEC)</li><li>– Marine Corps War College</li><li>– Marine Corps University International Fellows Program</li><li>– National Defense University</li><li>– Naval Command College</li><li>– Naval Staff College</li><li>– United States Marine Corps (USMC) Command and Staff College</li><li>– USMC Expeditionary Warfare School</li><li>– USMC School of Advanced Warfighting</li></ul> <p>Students are not encouraged to bring dependents to any other courses. The “with dependent” TLA rate is intended/authorized when the dependents reside with student for the majority (75%) of the course duration. The “with dependent” TLA rate is not intended/authorized for students with dependents who come only for periodic visits.</p>
