- 1. Medicare Part A 837 Status Report. See attached document received from Trailblazers Part A- Sandra Lahi- ITSC is working with Trailblazers and the Area leads to correct inaccuracies on the report. Will need input from sites to correct list and identify sites that still need to begin testing. Once the list is finalized, Dyanne and Catherine will be contacting those sites to assist with moving them toward 837 compliance. We will send out an accurate listing once all updates are received. ITSC will be working with Medicare B to obtain a similar list.
- 2. Area Training for Reading Error Reports and 837 file submission- Sandra Lahi- Dyanne is in the process of developing a training module to assist sites in learning to read 997 error reports, identify error trends, and how to make corrections. Classes will begin in early February 2005. The Areas who have requested this training is Aberdeen, Oklahoma and Alaska. Kathy from Bemidji also requested this training on the conference call.
- 3. <u>835 PNC Bank Project Catherine Thompkins</u>. PNC is moving rapidly. They are working on NV Medicaid, ND and SD Medicaid, Medi-Cal, and AZ BCBS. Portland is ready to begin testing with PI. PNC is trying to find a work-around to process NM Medicaid. They are now focusing on the Aberdeen area. They are also moving on Pharmacy-Advanced PCS-Express Scripts-Med Impact- First Health- and BCBS AZ XXC.
- 4. 2005 ICD 9 Code Set Updates. Catherine Thompkins. The new updates should be ready to test by the 20th, and expected to release by the first of the year.
- 5. <u>Updates to AR Standard Adjustment table Sandra Lahi.</u> There are also new updates to the Remittance Advice codes that ITSC is working to get developed into the A/R application.

Follow-Up Items

1. <u>Status of National Clearinghouse Contract Discussion- Sandra Lahi-</u> At the NBOC meeting in November, it was stated that they want two clearinghouse solutions. Headquarters East is now working on the scope of work with the contracting office. The issue is still pending.
