You'll need a yellow badge to enter Exchange headquarters

Effective 1 March 2012, Exchange headquarters has instituted a new visitors policy to better protect associates, equipment, property and proprietary information, Col. Tom Ockenfels, Chief of Staff, announced.

Any permanent badges that were issued to anyone who is not currently an associate (retirees and family members) were turned off on 1 March 2012. That means when a retiree (or other visitor) visits Hq. AAFES they will be issued a temporary visitors badge. To accommodate visitors, an additional computer station was installed at the South entrance to process temporary visitors and minimize delays on the entry point.

Within a short time, frequent visitors will be on file and should receive badges rapidly after arriving.

The greatest changes are in way visitor badges are issued. Exchange retirees and their family members, active duty military members not assigned to the Exchange and military family members will be issued a temporary yellow adhesive paper visitor's badge when entering the Headquarters and Stoneridge Buildings (used for the Exchange Catalog staff) that must be worn for the duration of the visit.

Visitors will present a valid identification card and sign in at the south security station. They will be issued a yellow visitor's decal on each visit. This change is not a move to ban anyone or be exclusionary, but rather to safeguard the people who work there and ongoing business, Colonel Ockenfels said.

That didn't happen because the Exchange announced during the day on March 30 that "not all of the required documentation to bring that about is complete." Welcome to the April, 2012 edition of AREA's Newsletter, and the first month of Spring

In January, I wrote about the water restrictions being imposed upon us due to the drought caused by La Nina. We have had a recent event that illustrates just how bad the drought really is.

In San Antonio, the Medina Lake is 52 feet down. It hasn't been this low in two decades, and the lake is expected to lose a few inches every day as the 15-month draught continues. To conserve and protect the 20,000 acre-feet of irrigation water dedicated to San Antonio, the board of Bexar-Medina-Atascosa Counties Water Control and Improvement District No. 1, which allocates the water behind the Medina Lake Dam, decided it would release only 10,000 acre-feet this year for irrigation. The water will be available from March 1 until mid-April. After that, there will be no more water for irrigation this year from the lake unless it rains.

The office manager of the BMA district said it will be up to the individual farmers if they want to take the chance of starting a crop without the assurance that there will be water for the rest of the growing season. Wow! Those are tough economic conditions. I wouldn't want to be in their shoes.

We had a board meeting on February 24th at the Credit Union conference room. HQ has changed the visitors admittance policy (see page 1) so we decided to hold the meeting at the Credit Union instead. At the meeting, we stated that we raised \$45,140 for the Scholarship fund last year through corporate and membership donations, scholarship booklet income and individual donations. (2011 scholarship income supports the 2012 program.) Our basic program will remain the same this year as it has for several years: 12 scholarships for a program total of \$40,000. Additional scholarship are optional, at the discretion of the committee, and subject to further board approval.

The North Texas chapter has started a program to generate income for the scholarship program that could easily be used by other chapters. It's called the "Tag-a-Long AREA Scholarship Program" Their board of directors voted to include an additional charge to major events in support of the AREA Scholarship Program. The "Tag-a-Long" was recently added to the "NTC Annual Holiday Dinner and Stroll" and netted \$225 for the Scholarship Program. The "Annual Valentine's Dinner" was the last event to include the "Tag-a-Long AREA Scholarship Program." Local chapters are encouraged to incorporate this simple idea to benefit the AAFES Community. This action makes it simple for Chapter members to contribute on a recurring basis to this important program. For more information, contact Richard Sheff at sheffrl@aol.com

the Exchange from a joint military command led by a Commander/CEO to a DoD joint instrumentality led by a senior non-appropriated Fund (NAF) executive civilian, including a Commander/CEO to a DoD joint instrumentality led by a senior non-appropriated Fund (NAF) executive civilian, including a General Order coordinated between the Departments of the Army and the Air Force, was not completed prior to the retirement of the Exchange's 32nd Commander/CEO, Maj. Gen. Bruce Casella. As a result, command of the Exchange was assumed by the next senior military officer assigned to the Exchange, which is Brigadier General Francis Hendricks. Brig. Gen. Hendricks will lead the Exchange through the next steps of this historical transition from a joint command to a joint instrumentality of the De-

partments of the Army and the Air Force. The Exchange is working closely with the Departments of the Army and the Air Force to complete the necessary documentation to effect a proper transition. This transition originated with the March 2011, Department of Defense initiative for General and Flag Officer efficiencies, which impact 140 General and Flag Officer positions throughout DoD, including the Commanding General billet at the Exchange. 2011 Benefits Comparison Study shows the Exchange is Still #1

Have you been wondering how the benefits the Exchange offers compares to other companies in our industry? We have received the results of our latest benefits comparison study from our consultant Towers Watson. The 2011 comparison study compared the Exchange with nine other companies: one convenience store, two fast food, and six retailers. The following employers were included in the study:

The study focuses on the major benefit categories:

- **Retirement** - evaluation of employer pension plans, 401(k) plan, post-retirement medical and post-retirement life benefits
- **Health** - evaluation of medical and dental benefits plans
- **Paid Time Off** - evaluation of vacation, holiday and sick leave benefits
- **Security** - evaluation of life insurance and short and long term disability income benefits.

As shown by the chart below, the Exchange is ranked highest in total benefits as we offer a full range of benefits to our employees and reward our long serving associates. Our programs tend to be very competitive or richer than private sector organizations.

The Benefits Branch starts the new year off running

The Exchange Benefits Branch has been busy launching new services and wellness initiatives.

Mypenpay.com is a new website for our retirees who are receiving a pension. This web site from our pension administrator, State Street, is for Exchange Retirees and provides access to pension payment history, payment detail, payment status, address of payment and tax elections. The website also gives retirees the ability to process changes to their payments including payment method changes, address changes and tax withholding changes. Using this website allows retirees to access their payment information at their convenience, anytime, day or night. Other things

they can access include the last 18 months of payment history, tax forms, and they may stop or reissue lost checks. To access the site go to <https://aafesretirement.mypenpay.com>. We also created a new site called **Retiree Self Service** for retirees to view some of the information they had access to as an employee under Employee Self Service. This portal allows retirees access to their Official Personnel Folder (OPF), W-2 Forms, Employment History, Training Records, Final Paycheck Stub, Awards

and Final eCOMPensation Statement. To access this site, go to the AREA homepage at <http://www.shopmyexchange.com/Community/AREA/> and find Retiree Self Service.

In an effort to help control medical claims costs, the benefits department has partnered with Aetna to create and mail out wellness **postcards** throughout the year. These postcards will be on various preventive care themes including a health incentive credit reminder, a preventive care exam reminder, and cancer screening reminders. The benefits branch is also developing other wellness related communications that will be sent out throughout the year.

Benefits Q & A

Often when our AAFES employees enter the world of retirement, there are questions concerning their benefits and how other items may affect those benefits. Listed below are the answers to recent questions received from AAFES retirees:

Q. Regarding the new Retiree Self Service Portal.....how will this system work for a widow who might need to access their deceased spouse's records?

A. Due to security/privacy issues when dealing with personal information, the spouse of a deceased Exchange employee would need to make a request for information through our office at either benefits@aafes.com or 1-800-519-3381. This information would not be available on the Retiree Self Service Portal.

Q. In the last newsletter it was mentioned that the hearing aid has a "maximum benefit" and "lifetime benefit" change to \$3,000 "every 3 years". Does this mean that the "maximum benefit" or "lifetime benefit" reverts to zero every 3 years? What does the "every 3 years" mean?"

A. Beginning in 2012, the hearing aid maximum benefit for Open Choice, Traditional Choice and Aetna International Plans will now cover \$3000 toward the purchase of a hearing aid (after deductible and coinsurance) every three years.

Call Aetna Rx Home Delivery toll-free at the number on the Order Form. Have your Aetna member ID number, your prescription number, and your credit card number ready.

3. By mail

Send in the reorder form that you received with your last order. Mail it back with your payment. The reorder form will also tell you when you can place your next refill order.

Gisela de Marco has been honored twice since receiving Germany’s highest civilian award, the Verdienstorden of the Bundesrepublik Deutschland—once, of course, at the German Consulate General in Houston, and now with an AREA Community Service Award (see page 11). The German award is given out on rare occasions. The Consul General told Gisela he had the opportunity to present it 10 times in 10 years of service as a Consul. “All in all, it is considered a high honor,” she said of the award. “There is none higher in Germany. I am proud of it and know that my husband would also have been proud. My six children and one granddaughter were present.” We asked Gisela to share some of her life story, and she came through beautifully with this heartfelt story about husband, Vic de Marco, and her life since she met Vic just after the war ended. Gisela, thank you. Congratulations!

Victor F. de Marco was my husband and father of our six children, Douglas, David, Adele, Karen, Kathleen and Chrissie. The Exchange Service brought us to Texas, and we are all still here; three in Houston, one in Dallas, one in San Antonio, and one in Beeville.

Vic, born and raised in Philadelphia, was a typical ‘South Philly’ first generation son of Italian immigrants. Vic was the youngest. After graduating from ‘South Philadelphia High’ in 1943, like most members of his class, he enlisted with the military before he was drafted. Once on the European continent, Vic had the distinction of fighting in the Battle of the Bulge. It must have been tough and scary. He never spoke about the situations which earned him the nick name ‘Lucky’.

At the end of WWII, Vic wound up guarding prisoners of war for two months in (then) Czechoslovakia.

His career with the exchange began while he was still on duty with the army. He was transferred to Munich in August 1945 when the European Exchange System (EES) opened the first Munich Post Exchange, THE PX, on Briennerstrasse.

Meanwhile I had graduated from high school in Munich, but could not attend a university because ‘study seats’ were held open for young men coming back from the war, unless a female student had already

completed a few semesters at the university. Food supply was short, all Germans lived with food coupons, and in order to receive food coupons, all Germans over 18 had to either have a job or be at the university in order to receive food coupons.

Well, you guessed it, I applied for work at the new PX, and PFC de Marco hired me to be the ‘information lady’ at the front desk of the PX. We were married four years later in Philadelphia. Vic left the army in 1946, and began a two-year stint as a civilian, working as an accountant with EES in Munich.

Vic returned to Philadelphia and enrolled at LaSalle University, a Christian Brothers School. Six months later, I followed him, and we were married between his first and second semester. Vic received a BA, maxima cum laude, in 1952. Since his dream was to become a CPA, he had to work for two years for a public accounting firm. He passed the CPA exam in 1953.

We both wanted to see Europe again; Vic applied with Exchange Headquarters in NY, and by December 1954 we were on our way to London with our first baby in tow. After a temporary assignment in Casablanca, in May 1955 Vic was trans-



ferred to Germany where he held several positions, not all in accounting, at the new European exchange headquarters in Wiesbaden. Wiesbaden was a great location for us as a family, and for me to give birth to three more children.

In 1962 we were transferred to NY to worldwide headquarters of AAFES. I believe he was Assistant Controller to Rudy Matthews at that time. Working in NY, he took also attended NYU, and in 1964 he received an MA. Our fifth child was born in Middlesex County, N.J. during that time.

In 1966, Vic became the controller in Hawaii. Our sixth child was born in Honolulu. Raising so many children was expensive; to make ends meet, Vic taught accounting night courses at many universities. In 1968, he was transferred to Dallas after headquarters moved from NY to Oak Cliff. During that time he had the opportunity to attend ‘Post Management’ summer courses at Harvard University.

In 1974 Vic was transferred, again, to Wiesbaden. General Arthur Gregg, Vic’s boss, lived across the street from us. In 1976, the general was transferred to Washington; Vic was transferred back to Dallas. He was able to get early retirement in 1980, and stepped immediately into a finance teaching position at UTD.

To my great sorrow, Vic passed away March 18, 1982.
