COMMISSION ANNOUNCEMENTS

COMMISSION TO HOLD ROUNDTABLE ON INTERNATIONALIZATION

The Commission today announced participants in an upcoming roundtable on internationalization. The Roundtable will be held on February 17 from 9:30 a.m. to 4:30 p.m. in the Commission meeting room, Room 1C30, 450 Fifth Street, NW, Washington, DC 20549. (Press Release 87-10)

ADMINISTRATIVE PROCEEDINGS

JOSEPH M. ELLIS SANCTIONED

The Commission instituted public administrative proceedings under Sections 15(b) and 19(h) of the Securities Exchange Act of 1934 against Joseph M. Ellis, formerly a registered representative of broker-dealers located in Grand Rapids, Michigan. Simultaneously, the Commission accepted Ellis' Offer of Settlement in which, without admitting or denying any of the Commission's findings, Ellis consented to an order barring him from association with any broker, dealer, investment adviser, investment company, or municipal securities dealer, provided, however, that at the end of the 15-month period, Ellis may apply to become so associated.

The Commission found that Ellis violated and aided and abetted violations of the registration provisions in connection with the offer and sale of securities issued by Horizon Oil & Gas, Inc. It further found that Ellis misrepresented material facts regarding the risks and returns associated with an investment. (Rel. 34-24015)

CIVIL PROCEEDINGS

DALE F. MYERS ENJOINED

The U.S. District Court for the District of Columbia entered a final judgment on February 9 permanently enjoining Dale F. Myers, an attorney, from violating the registration provisions of the Securities Act of 1933 and antifraud provisions of the Securities Act of 1933 and Securities Exchange Act of 1934. In its complaint, filed on October 15, 1986, the Commission alleged that Myers violated the antifraud provisions in connection with the offer and sale of securities of Quantum Financial Services, Inc. and ProTech Accounting Corporation, then known as Managed Accounting Services, Inc., and that he violated the registration provisions in connection with the sale of these and other securities. Myers consented to the final judgment without admitting or denying the allegations in the Commission's complaint. (SEC v. Balanced Financial Management, Inc., et al., USDC DC, Civil Action No. 86-2818). (LR-11352)

INVESTMENT COMPANY ACT RELEASES

TAX-FREE INVESTMENT TRUST

A notice has been issued giving interested persons until February 26 to request a hearing on application of Tax-Free Investment Trust (formerly, Tax-Free Cash Reserves, Inc.), Short-Term Investments Co., Alex. Brown Cash Reserve Fund, AIM Advisors, Inc., and Alex. Brown & Sons Incorporated for an order amending an existing order (Rel. IC-14695, August 27, 1985) permitting the establishment of separate classes of shares within the same investment portfolio, and the allocation of certain expenses and voting privileges associated with such classes. (Rel. IC-15570 - Feb. 6)

M.D.C. MORTGAGE FUNDING CORPORATION II

An order has been issued exempting M.D.C. Mortgage Funding Corporation II and certain trusts created by it from all provisions of the Investment Company Act in connection with the issuance of mortgage-backed securities. (Rel. IC-15571 - Feb. 9)

HOLDING COMPANY ACT RELEASES

ALLEGHENY GENERATING COMPANY

A supplemental order has been issued with respect to Allegheny Generating Company (AGC), subsidiary of Allegheny Power System, Inc., releasing jurisdiction over the terms and conditions of the issuance and sale by AGC of \$100 million of debentures through a negotiated offering as the initial step in providing permanent financing of its 40% interest in the Bath County (Virginia) Pumped Storage Project. Jurisdiction has been reserved over the terms and conditions of the issuance and sale of an additional \$100 million of debentures. (Rel. 35-24307 - Feb. 2)

NATIONAL FUEL GAS COMPANY

A supplemental order has been issued releasing jurisdiction previously reserved with regard to National Fuel Gas Supply Corporation (Supply) in a prior Commission order (Rel. 35-24175, August 28, 1986), which, among other things, authorized National Fuel Gas Company (National), a registered holding company, to acquire, and its subsidiaries National Fuel Gas Distribution Corporation, Penn-York Energy Corporation and Supply, to issue and sell to National, promissory notes (Notes) in an aggregate principal amount of up to \$250 million. This order authorizes the issuance and sale by Supply of Notes to National in an aggregate principal amount of up to \$75 million for the purpose of financing construction of pipeline as part of Supply's Boundary project. (Rel. 35-24309 - Feb. 4)

Persons eligible to use the short form (Schedule 13G) may in lieu of filing a Schedule 13D file a Schedule 13G within 45 days after the end of the calendar year in which the person became subject to Section 13(d)(1). Companies and individuals making a tender offer must have on file at the time the tender offer commences a Schedule 14D-1.
