ADMINISTRATIVE PROCEEDINGS

ORDER INSTITUTING PROCEEDINGS AND IMPOSING REMEDIAL SANCTIONS AGAINST ELLEN ZIVITZ

The Commission ordered public administrative proceedings under Sections 15(b) and 19(h) of the Securities Exchange Act of 1934 against Ellen Zivitz, a registered representative. Simultaneously, Zivitz submitted an Offer of Settlement which the Commission accepted. Zivitz consented, without admitting or denying the findings in the Order, to the Commission's Order making findings that she wilfully violated and aided and abetted various antifraud provisions of the securities laws in the offer, sale, and purchase of three new issues underwritten in 1983 by Brooks, Hamburger, Satnick, Inc. (BHS), a broker-dealer formerly registered with the Commission.

The Order suspends Zivitz for 30 days from association with any broker, dealer, investment company, investment adviser, or municipal securities dealer in any capacity. The Order further requires Zivitz for six months from the date of the Order to comply with certain undertakings with respect to recommendations and preparation of sales literature. (Rel. 34-24074)

ORDER INSTITUTING PROCEEDINGS AND IMPOSING REMEDIAL SANCTIONS AGAINST GENNARO MAFFEI

The Commission instituted public administrative proceedings under Sections 15(b) and 19(h) of the Securities Exchange Act of 1934 against Gennaro Maffei, a registered representative at a registered broker-dealer and formerly associated with Brooks, Hamburger, Satnick, Inc., a broker-dealer formerly registered with the Commission. Simultaneously, the Commission accepted his Offer of Settlement. Maffei consented, without admitting or denying the allegations or findings in the Order, to findings that he wilfully violated and aided and abetted violations of various antifraud provisions of the securities laws. Maffei was suspended, pursuant to his consent, from association with any broker, dealer, investment company, investment adviser, or municipal securities dealer in any capacity for three months and agreed to comply with certain undertakings.

In a related action, Maffei consented to an injunction against future violations of the sections and rules of the securities laws charged against him without admitting or denying the allegations of the Commission's complaint. Maffei also agreed to disgorge the sum of \$14,000 as ancillary relief. (Rel. 34-24075)

ORDER INSTITUTING PROCEEDINGS AND IMPOSING REMEDIAL SANCTIONS AGAINST ROBERT BEERS

The Commission instituted public administrative proceedings under Sections 15(b) and 19(h) of the Securities Exchange Act of 1934 against Robert Beers, general counsel to Brooks, Hamburger, Satnick, Inc. (BHS), a broker-dealer formerly registered with the Commission. Simultaneously, Beers submitted an Offer of Settlement which the Commission accepted. Beers consented, without admitting or denying the findings in the order, to the Commission's Order making findings that he failed reasonably to supervise employees of BHS in connection with three BHS underwritings in 1983. The Order suspends Beers for six months from association with any broker, dealer, investment company, investment adviser, or municipal securities dealer in any supervisory, proprietary, managerial or compliance capacity. The Order also requires Beers to comply with undertakings to complete within one year of the effective date of the Order a total of 40 hours of professional seminars or college courses in topics relating to regulatory requirements and compliance and not to engage in compliance activities until such courses are completed. HOLDING COMPANY ACT RELEASES

COLUMBIA GAS SYSTEM, INC.

A notice has been issued giving interested persons until March 9 to request a hearing on a joint proposal by the following companies filed under Release 35-24317, dated February 12, 1987: Columbia Gas System, Inc. - a registered holding company, and its subsidiaries, Columbia Gas System Service Corporation, Columbia Hydrocarbon Corporation, Columbia Coal Gasification Corporation, The Inland Gas Company, Inc., Columbia Gas Transmission Corporation, Columbia Gas of Kentucky, Inc., Columbia Gas of Maryland, Inc., Columbia Gas of New York, Inc., Columbia Gas of Ohio, Inc., Columbia Gas of Pennsylvania, Inc., Columbia Gas of Virginia, Inc., Columbia Gulf Transmission Company, Columbia Gas Development Corporation, Columbia Gas Development of Canada, Ltd., Commonwealth Gas Pipeline Corporation, and Commonwealth Gas Services, Inc. Columbia proposes to refund, during the years 1987 and 1988, certain of the subsidiaries' installment promissory notes up to an aggregate principal amount of \$334,979,466, with interest rates from 10.2% to 15.6%, for a like principal amount of lower cost, unsecured installment promissory notes to be issued by the subsidiaries to Columbia at an interest rate to approximate that of the corresponding Columbia debenture issue.

SELF-REGULATORY ORGANIZATIONS

APPROVAL OF PROPOSED RULE CHANGE

The Commission approved a proposed rule change filed by the Chicago Board Options Exchange (SR-CBOE-85-52) to allow its member organizations, including clearing firms, to establish their own exercise cut-off times, consistent with the rules of the Options Clearing Corporation, for foreign currency options.
