PROXY PROCESSING RULES DEFERRED

## TRADING SUSPENSIONS

TRADING SUSPENDED IN SECURITIES OF GSS VENTURE CAPITAL CORP. AND SHERWOOD FINANCIAL LTD. SECURITIES

The Commission announced the single ten-day suspension of over-the-counter trading in the securities of GSS Venture Capital Corporation (GSS), a Florida corporation currently headquartered in Fort Lauderdale and in the securities of Sherwood Financial Ltd. (Sherwood Financial), a Utah corporation currently headquartered in Orem, Utah for the period beginning at 12:00 noon on June 17, 1987 and terminating at midnight (EST) on June 26, 1987. The Commission suspended trading of GSS and Sherwood Financial securities because of a lack of current and accurate information and in view of questions that have been raised about the adequacy and accuracy of publicly disseminated information concerning, among other things: a pending acquisition offer for all of GSS's issued and outstanding common stock by Sherwood Financial Ltd.; the financial condition of GSS and Sherwood Financial and the management of Sherwood Financial. ### TRADING OF JOCOM SECURITIES SUSPENDED

The Atlanta Regional and Miami Branch Offices announced that on June 18 the Commission temporarily suspended over-the-counter trading of the securities of Jocom, Inc., a business entity with offices in Hattiesburg, Mississippi, for the ten-day period commencing at 10:00 a.m. on June 19, 1987 and terminating at 10:00 a.m. (EDT) on June 29, 1987.

The Commission temporarily suspended trading in the securities of Jocom because of a lack of current financial statements, its failure to disclose the suspension of its corporate operations, and in view of questions that have been raised about the adequacy and accuracy of publicly disseminated information concerning the nature of Jocom's assets and its acquisitions of other businesses. ## CIVIL PROCEEDINGS

COMPLAINT NAMES GSS VENTURE CAPITAL CORP., SHERWOOD FINANCIAL, LTD.

The Chicago Regional Office filed a complaint on June 17 in the U.S. District Court for the Northern District of Illinois, Eastern Division, seeking to preliminarily and permanently enjoin GSS Venture Capital Corporation (GSS) of Ft. Lauderdale, Florida, and Sherwood Financial Ltd. (Sherwood) of Orem, Utah, from further violations of the antifraud and registration provsions of the federal securities laws. The complaint alleges that in connection with a proposed offer by Sherwood to acquire all of the issued and outstanding stock of GSS, the two companies failed to disclose, among other things information concerning the financial condition, assets and capitalization of GSS and Sherwood, the unregistered status of the exchange offer and the underlying reasons for GSS' board of directors' approving an exchange on a two-for-one basis. In a related matter, the Commission also suspended trading in the securities of GSS and Sherwood for a ten-day period. (SEC v. GSS Venture Capital Corporation and Sherwood Financial, Ltd. (N.D. An order has been issued granting The Travelers Insurance Company and The Travelers Fund UL for Variable Life Insurance, exemptions from Section 2(a)(32), 22(c), 26(a)(2), 27(c)(1), 27(c)(2) and 27(d) of the Act and Rules 6e-3(T)(b)(12), 6e-3(T)(b)(13), 6e-3(T)(c)(2) and 22c-1 thereunder, to permit (1) the deduction of a deferred administration charge under surrender of the Contract during the first 10 contract years or the 10 years following an increase in stated amount and (2) the Premium Waiver Rider to be treated as incidental insurance benefits, in connection with the issuance of flexible premium variable life insurance contracts.
