### **RULES AND RELATED MATTERS**

AMENDMENTS ADOPTED CONCERNING REPURCHASE AGREEMENTS
AND FINANCIAL RESPONSIBILITY RULES FOR BROKERS AND DEALERS

The Commission adopted amendments to the customer protection rule relating to repurchase agreements. Rule 15c3-3 is amended to require broker-dealers that agree to retain securities subject to repurchase agreements to: (a) make specific disclosures regarding the risks associated with those transactions; (b) disclose that the Securities Investor Protection Corporation has taken the position that coverage under the Securities Investor Protection Act of 1970 may not be available to the counterparty; and (c) maintain such securities free of any lien at the end of each trading day. #### **CIVIL PROCEEDINGS**

COMPLAINT FILED AGAINST PAUL DAVID HERRLINGER

The Chicago Regional Office filed a complaint on July 16 in the U.S. District Court for the Southern District of Ohio seeking a permanent injunction against Paul David Herrlinger. The complaint alleges that Herrlinger: violated the antifraud and tender offer provisions of the Securities Exchange Act of 1934 and Rule 10b-5; announced a tender offer for the shares of Dayton Hudson Corporation while knowing that he did not have the finances or access to the finances necessary to fund the tender offer; and failed to provide investors with sufficient information concerning the tender offer. The complaint also seeks disgorgement of the profits that Herrlinger realized from his trading of options on Dayton Hudson stock the day before the announcement. (SEC v. Paul David Herrlinger, SDOH, Civil Action No. C-1-87-577, filed July 16, 1987). (LR-11504)

## **INVESTMENT COMPANY ACT RELEASES**

UNITED INVESTORS LIFE INSURANCE COMPANY

An order has been issued granting United Investors Life Insurance Company, United Investors Annuity Variable Account, and United Investors Equity Services, Inc. exemptions from the provisions of Sections 2(a)(35), 26(a)(2)(C), and 27(c)(2) of the Investment Company Act to permit a sales expense charge to be deducted from the assets of the Variable Account on each of the first ten contract anniversary dates and the deduction of mortality and expense risk charges from the assets of the Variable Account. (Rel. IC-15907 - Aug. 5)

An order has been issued exempting The Equitable Life Assurance Society of the United States (Equitable), Separate Account A of Equitable (SA-A), Separate Account C of Equitable (SA-C), Separate Account D of Equitable (SA-D), Separate Account E of Equitable (SA-E), Separate Account J of Equitable (SA-J), and Separate Account K of Equitable (SA-K) (collectively, Separate Accounts) and The Equitable Trust (collectively, Applicants) and certain transactions from Section 17(a) and also approving such transactions under Section 17(d) and Rule 17d-1. The exemption will permit the: (a) combination of SA-C into SA-A, and then the combination of SA-D, SA-E, SA-J, and SA-K into SA-A; (b) simultaneous reconstruction of SA-A into a unit investment trust; and (c) simultaneous issuance of shares of the Trust to SA-A, as proposed to be reconstructed, in exchange for all of the assets, and related liabilities, of the Separate Accounts. An order has also been issued for exemptions from Sections 26(a)(2)(C) and 27(c)(2) of the Act to permit the deduction of certain mortality and expense risk charges and death benefit charges under certain variable annuity contracts.
