## ADMINISTRATIVE PROCEEDINGS

---

### HUGH F. SACKETT SANCTIONED

The Commission instituted public administrative proceedings under Sections 15(b) and 19(h) of the Securities Exchange Act of 1934 and Section 203(f) of the Investment Advisers Act of 1940 against Hugh F. Sackett, formerly associated with registered broker-dealer and investment adviser entities. Simultaneously, the Commission accepted Sackett's Offer of Settlement in which, without admitting or denying the Commission's findings, except for the finding that he was permanently enjoined by the U.S. District Court for the Southern District of California from future violations of the registration and antifraud provisions of the Securities Act of 1933 and the Exchange Act in SEC v. W. Carl Zimmerman and Hugh F. Sackett, No. 86-1846 N (CM) (SDCA), he consented to an order barring him from association with any broker, dealer, investment adviser, investment company, or municipal securities dealer, provided, however, that at the end of two years, he may apply to become so associated.

Sackett consented to the permanent injunction on which the administrative proceeding was based. The civil action arose from Sackett's participation in the offer and sale of unregistered securities in the form of limited partnership interests and debentures in approximately 70 offerings which raised over \$90 million from at least 2,500 investors. ### ALGEMENE SPAAR-EN LIJFRENTKAS/CAISSE GENERALE D'EPARGNE ET DE RETRAITE

(the Funds), and Fidelity Management & Research Company (FMR) determining that under Section 2(a)(19) of the Investment Company Act the Funds' proposed independent general partners shall not be deemed interested persons of the Funds or FMR, their investment adviser, solely because of their status as general partners of the Funds. ## HOLDING COMPANY ACT RELEASES

---

### ATLANTIC ENERGY, INC.

An order has been issued authorizing Atlantic Energy, Inc., an inactive subsidiary of Atlantic City Electric Company, to acquire all of the outstanding common shares of Atlantic Electric in order to effect a merger between Atlantic Electric and a subsidiary of Atlantic Energy to be organized. Atlantic Electric will be the surviving corporation. It is stated that Atlantic Electric seeks a more appropriate corporate structure in order to diversify on a limited basis into nonutility activities. Following the proposed merger, Atlantic Energy expects that both Atlantic Electric and itself will continue to meet the requirements for exemption of Section 3(a)(1) and/or (2) of the Public Utility Holding Company Act of 1935 and Rule 2. The New Jersey Board of Public Utilities issued an order on January 5 approving the proposed restructuring and related transactions. (Rel. 35-24475 - Oct. 15)
