COMMISSION ANNOUNCEMENTS

SEC CITES RONALD G. FARRELL. Public administrative proceedings have been ordered to take evidence on the staff's allegations that Ronald G. Farrell wilfully violated and wilfully aided and abetted violations of the registration provisions in the offer and sale of stock in Equity Holding Corporation and First Equity Corporation, and the anti-fraud provisions of securities laws in the offer and sale of stock of First Equity Corporation and Investment Enterprises Incorporated. In addition, it is alleged that Farrell aided and abetted a registered broker-dealer in violations of the net capital, reserve and custody of securities, financial reporting, bookkeeping, broker-dealer registration, customer reporting, quarterly box count, and the supervision provisions of the Securities Exchange Act of 1934, and Regulation T promulgated by the Board of Governors of the Federal Reserve Board. A hearing will be scheduled by further order to take evidence on the staff allegations and to afford the respondent an opportunity to offer any defenses thereto. The hearing will determine whether any action of a remedial nature should be ordered by the Commission. (Rel. 34-10561)

HOLDING COMPANY ACT RELEASES

SYSTEM FUELS, INC. The SEC has authorized System Fuels, Inc., a jointly-owned non-utility subsidiary of the operating subsidiary companies of Middle South Utilities, to, among other things, borrow from the Operating Companies from time to time through December 31, 1975, an aggregate amount not to exceed \$90 million outstanding at any one time. The borrowings will be made, to the extent outside financing is unavailable, to provide capital for SFI's fuel supply programs. (Rel. 35-18221)

AMERICAN NATURAL GAS. An order has been issued authorizing American Natural Gas Company and its subsidiaries to sell all of the 63,219 outstanding common shares of Central Indiana Gas Company, wholly-owned subsidiary of American Natural, to Indiana Gas Company, Inc., a non-affiliated exempt holding company, for \$20.5 million. INVESTMENT COMPANY ACT RELEASES

OPPENHEIMER SYSTEMATIC CAPITAL ACCUMULATION PROGRAM. A notice has been issued giving interested persons until January 8 to request a hearing on an application of Oppenheimer Systematic Capital Accumulation Program, Oppenheimer Time Fund Capital Accumulation Program and Capital Accumulation Program of Shares of Oppenheimer A.I.M. Fund (the "Trusts"), each of which is registered as a unit investment trust under the Investment Company Act of 1940, and Oppenheimer Management Corporation, for an order permitting plans issued by the trusts to be exchanged, under certain conditions, for plans issued by the other trusts without any deductions for sales or administrative expenses. STANDARD & POOR'S/INTERCAPITAL INCOME SECURITIES, INC. An order has been issued on an application of Standard & Poor's/Intercapital Income Securities, Inc., a registered closed-end investment company, declaring that John J.
