CIVIL PROCEEDINGS

BRETT A. BERNSTEIN PRELIMINARILY ENJOINED

The Atlanta Regional and Miami Branch Offices announced that on January 12 the Hon. Jose A. Gonzalez, U.S. District Judge for the Southern District of Florida, preliminarily enjoined Brett A. Bernstein of Boca Raton, Florida, from violating the antifraud, registration and recordkeeping provisions of the federal securities laws. Bernstein was formerly the branch manager at the Tampa, Florida office of F.D. Roberts Securities, Inc., a registered broker-dealer which ceased operations in February 1989. Bernstein consented to the entry of the judgment without admitting or denying the allegations in the complaint.

The Commission's complaint, filed November 20, 1989, alleges that the defendants caused F.D. Roberts to manipulate the market for the securities of Frankel Capital Management, Inc. and Integrated Financial Group, Inc. by, among other things, placing the securities in "nominee" accounts during the respective initial public offerings, redistributing the securities in the secondary market at artificial price levels, and making numerous misrepresentations and omissions of material facts to investors and prospective investors in the securities. INVESTMENT COMPANY ACT RELEASES

PRUDENTIAL-BACHE CALIFORNIA MUNICIPAL FUND

An order has been issued on an application under Section 6(c) of the Investment Company, granting exemptions from Sections 18(f), 18(g) and 18(i) of the Act to the extent necessary to permit Prudential-Bache California Municipal Fund, et al. and future funds that are part of the Prudential-Bache "group of funds" to issue and sell separate classes of securities for the propose of establishing a dual distribution system; and from the provisions of the Sections 2(a)(32), 2(a)(35), 22(c) and 22(d) of the Act and Rule 22c-1 to the extent necessary to permit the assessment of a contingent deferred sales load on certain redemptions of a class of their securities, and to waive the contingent deferred sales load on certain redemptions. HOLDING COMPANY ACT RELEASES

ENERGY INITIATIVES, INCORPORATED CONSOLIDATED NATURAL GAS COMPANY

Notices have been issued giving interested persons until February 5 to request a hearing on proposals by: ENERGY INITIATIVES, INCORPORATED (EII), Armstrong Energy Corporation (Armstrong), and AEC/REF-Fuel Limited Partnership (Partnership), each an indirect subsidiary of General Public Utilities Corporation. EII proposes to make up to \$2,000,000 million of additional capital contributions to Armstrong from time to time through December 31, 1991. Armstrong proposes to make such capital contributions, in turn, to the Partnership. The Partnership proposes to use such funds to pay project development expenses and make additional investments in a proposed waste coal-fired generating facility which will be a qualified facility under the Public Utility Regulatory Policies Act of 1978; and CONSOLIDATED NATURAL GAS COMPANY to issue and sell, through December 31, 1990, up to four million shares of its authorized but unissued common stock (\$2.75 par) (Additional Stock).
