# ADMINISTRATIVE PROCEEDINGS

# WALTON FREDERICK CARLISLE AND LYLE THOMAS BACHMAN SANCTIONED

The Commission instituted public administrative proceedings against Walton Frederick Carlisle of Jacksonville, Florida, and Lyle Thomas Bachman of Tulsa, Oklahoma, under the Securities Exchange Act and the Securities Investor Protection Act. The proceedings are based, in part, on the facts alleged in a Complaint filed by the Commission and the entry of permanent injunctions by consent against Fitzgerald, DeArman & Roberts, Inc., a Tulsa, Oklahoma broker-dealer, presently in liquidation under a SIPC trusteeship, as well as Carlisle and Bachman on January 4, 1989 (SEC v. Fitzgerald, DeArman & Roberts, Inc., Walton Frederick Carlisle and Lyle Thomas Bachman, Civil Action No. 88C 601 C, USDC/ND/Okla.). Simultaneously, the Commission accepted an Offer of Settlement submitted by each individual providing for a Commission order making findings of fact and instituting remedial sanctions.

The Commission found that Carlisle and Bachman were officers and controlling persons of Fitzgerald, DeArman & Roberts, Inc. and, in those capacities, aided and abetted the firm's violations of Sections 15(c)(2) and 15(c)(3) of the Securities Exchange Act and related Rules 15c2-1, 15c3-1 and 15c3-3. The Commission's order provides that Carlisle and Bachman be barred from association with any broker or dealer in back office supervisory or proprietary capacities, provided that each may apply to become so associated after a period of five years. #### INVESTMENT COMPANY ACT RELEASES

### COMMUNITY INVESTMENT PARTNERS, L.P.

A notice has been issued giving interested persons until February 19 to request a hearing on an application filed by Community Investment Partners, L.P. (the Partnership) and CIP Management, L.P. (Managing General Partner) for an order under Section 6(c) of the Investment Company Act that would grant an exemption from the provisions of Sections 2(a)(19) and 2(a)(3)(D). The requested order would determine that (i) the Independent General Partners of the Partnership would not be interested

persons of the Partnership, the Managing General Partner, Edward D. Jones & Co, L.P. (Jones), or The Jones Financial Companies, a Limited Partnership (JFC), solely by reason of being general partners of the Partnership and co-partners of the Managing General Partner, and (ii) persons who become limited partners (Limited Partners) of the Partnership and who own less than 5% of the limited partnership interests in the Partnership would not be affiliated persons of the Partnership, any other Limited Partner, any of the Individual General partners, the Managing General Partner, Jones, or JFC solely because such Limited Partners are partners of the Partnership and any of such other persons are partners with one another in the Partnership. #### NEW ENGLAND ELECTRIC SYSTEM
