COMMISSION ANNOUNCEMENTS

EXECUTIVE DIRECTOR TO LEAVE COMMISSION

The SEC today announced that George Kundahl, Executive Director, will leave the Commission in mid-February to become Principal Deputy Assistant Secretary of Defense for Reserve Affairs. Mr. Kundahl has served in the U.S. Army Reserve since 1962, and has been nominated by the President to the rank of Brigadier General. He served as Executive Director since November 1981, and before that spent nearly five years as Deputy Executive Director.

In making the announcement, Chairman Richard C. Breeden applauded Mr. Kundahl's outstanding contributions to the agency's management. Mr. Breeden said: "I am sure

that I speak for all the Commissioners and the entire Commission staff in expressing our gratitude for the outstanding job that George Kundahl has done as Executive Director. I have found George to have excellent judgment and good leadership skills, and complete loyalty to the Commission. I regret his departure so early in my tenure as Chairman." (Press Release 90-8)

CANCELLATION OF INVESTMENT ADVISER REGISTRATIONS

ADMINISTRATIVE PROCEEDINGS

PROCEEDINGS INSTITUTED AGAINST HERBERT L. CANTLEY

The Commission instituted public administrative proceedings under Sections 15(b) and 19(h) of the Securities Exchange Act against Herbert L. Cantley (Cantley). The Order instituting proceedings is based upon Cantley's conviction by a federal jury on February 25, 1987, which was upheld on appeal by the Third Circuit, of one count of aiding and abetting the operation of a multi-state illegal gambling business [United States v. Mastronardo, Criminal No. 87-1525, 1528, 1541, 1561 and 1644 (3d Cir. June 13, 1988)]. The Order alleges that, as part of an attempt to conceal proceeds from the gambling business, Cantley, among other things, used his position as a registered representative to open two nominee accounts with his employer, a registered broker-dealer, and utilized these accounts to convert the gambling business' unlawfully earned and reported currency into municipal bonds. TRADING SUSPENSIONS

BOLAR PHARMACEUTICAL CO., INC. SECURITIES SUSPENDED

The Commission announced the temporary suspension of trading in the securities of Bolar Pharmaceutical Co., Inc. for the ten-day period beginning at 9:30 a.m. (EST) on January 25, 1990 and terminating at 11:59 p.m. (EST) on February 3, 1990.

The Commission temporarily suspended trading in the securities of Bolar because of the lack of adequate current information concerning the recent public disclosure that certain false documents were submitted to the Food and Drug Administration (FDA) in connection with Bolar's Abbreviated New Drug Application (ANDA) 71-845. Questions have been raised about the adequacy and accuracy of publicly disseminated information concerning, among other things, the effect of the falsity of these documents on the ANDA and the effect that any change in the status of the ANDA would have on the financial position of the company.

Persons eligible to use the short form (Schedule 13G) may in lieu of filing a Schedule 13D file a Schedule 13G within 45 days after the end of the calendar year in which the person became subject to Section 13(d)(1). Companies and individuals making a tender offer must have on file at the time the tender offer commences a Schedule 14D-1.
