ADMINISTRATIVE PROCEEDINGS

FINAL DECISION DENYING REGISTRATION TO J.B.T. MANAGEMENT, INC., D/B/A/ TUTTLE INCORPORATED, AND SUSPENDING JASON B. TUTTLE, SR. AND JASON B. TUTTLE, JR. FINAL

The decision of an administrative law judge denying the application of J.B.T. Management, Inc., d/b/a Tuttle Incorporated, of Palm Beach, Florida, for registration as an investment adviser, and suspending Jason Baker Tuttle, Sr., applicant's chairman, and Jason Baker Tuttle, Jr., its president, from association with any investment adviser for a period of six months has become final. The law judge found that applicant misstated information on its registration application concerning a pending Commission disciplinary proceeding involving Tuttle Sr. and two investment advisers he controls, and omitted other required information about that proceeding and about Tuttle Sr.'s prior bankruptcy proceedings. The law judge also found that the Tuttles, applicant's sole owners, were responsible for the misstatements and omissions. The Tuttles' suspensions are effective February 5. (Rel. IA-1218)

STEIN ROE & FARNHAM, INC. CENSURED

The Commission announced the institution of public administrative proceedings under Section 203(e) of the Investment Advisers Act against Stein Roe & Farnham, Inc. (Stein Roe), a Chicago-based investment adviser. Simultaneously, the Commission made findings and imposed remedial sanctions pursuant to Respondent's Offer of Settlement, wherein it neither admits nor denies the findings. The Commission found that Stein Roe violated Section 17(e)(1) of the Investment Company Act in connection with its advisory relationship with its mutual funds. Specifically, the Order found that Stein Roe engaged in a brokerage allocation practice which involved obtaining client referrals for its advisory business through the use of its mutual fund clients' brokerage commissions. The Order censures Stein Roe and requires it to comply with its undertaking to establish procedures designed to prevent courses of business which result in actual or potential conflicts of interests concerning Funds' assets. CANADA LIFE INSURANCE COMPANY OF NEW YORK
