# CRIMINAL PROCEEDINGS

ROGER G. COLEMAN, SR. INDICTED

The Denver Regional Office, the Salt Lake City Branch Office and the U.S. Attorney for the District of Utah announced that, on March 28, Roger G. Coleman, Sr. of Salt Lake City, Utah, was indicted on one count of conspiracy to commit securities fraud and to transport counterfeited securities in interstate commerce and on one count of interstate transportation of counterfeited securities.

The indictment alleges that Coleman conspired with another to take a fraudulently counterfeited stock certificate representing 150,000 shares of stock of Fuji Electrocell Corp. from Salt Lake City, Utah, to San Diego, California, to pledge as collateral for a bank loan. Coleman is said to have counterfeited the stock certificate. Allegedly, Coleman then gave the counterfeited stock certificate to his co-conspirator who took it from Salt Lake City to San Diego. ## AMERICAN MEDICAL TECHNOLOGY

The Commission, on March 16, announced objections to American Medical Technology's (Debtor's) plan and disclosure statement in its pending reorganization involving a

publicly-held shell corporation with no assets and no business operations. The Commission objected that the plan was non-confirmable because Debtor would emerge from bankruptcy with no assets and its "business" would have consisted of seeking new business opportunities. The bankruptcy court agreed with the Commission's objections and denied approval of the Debtor's disclosure statement as well as confirmation of its plan. (Rel. CR-387)

#### NOTICE OF PROPOSED RULE CHANGES

Proposed rule changes have been filed by: <u>National Securities Clearing Corporation</u> (SR-NSCC-89-19) to modify NSCC's Continuous Net Settlement buy-in procedures in connection with short sales to require that in the event of retransmittal of buy-in notices the NSCC members having the oldest relevant short positions would be held liable for an executed buy-in; and (SR-NSCC-89-17) to permit automated communication of buy-in notices among NSCC members.
