#### INVESTMENT COMPANY ACT RELEASES

ACM HIGH INCOME FUND

An order has been issued under Section 8(f) of the Investment Company Act declaring that ACM High Income Fund, Inc. has ceased to be an investment company. (Rel. IC-17421 - Apr. 11)

TECHNOLOGY FUNDING VENTURE PARTNERS V, AN AGGRESSIVE GROWTH FUND, L.P.

A conditional order has been issued under Section 6(c) of the Investment Company Act on an application filed by Technology Funding Venture Partners V, An Aggressive Growth Fund, L.P. (Partnership), Technology Funding Inc., and Technology Funding Ltd., determining that: (1) the independent general partners of the Partnership are not "interested persons" of the Partnership, the other general partners, or the principal underwriter of the Partnership solely by reason of their status as general partners of the Partnership and co-partners of the other general partners of the Partnership; and (2) no limited partner owning less than five percent of the units of limited partnership interest in the Partnership is an "affiliated person" of the Partnership or any of its partners solely by reason of being a limited partner of the Partnership and a co-partner of the other limited partners and the general partners.
