# ADMINISTRATIVE PROCEEDINGS

MYSORE SUNDARA BARRED, MYSORE SUNDARA & ASSOCIATES REGISTRATION REVOKED

On September 10, the Chicago Regional Office announced that the Commission has ordered that Mysore S. Sundara (Sundara) be permanently barred from association with any broker, dealer or investment adviser. The Commission has also ordered that the investment adviser registration of Sundara's company, Mysore S. Sundara & Associates, Inc. (MSA) be revoked. Sundara and MSA failed to answer the order which instituted administrative proceedings on May 30, 1990. The Commission found, based on the order instituting the proceedings, that Sundara was a registered representative associated with a registered broker-dealer and was the president and sole shareholder of MSA. a registered investment adviser. On April 19, 1990, Sundara was convicted of two counts of deceptive business practices in the Lake County, Illinois criminal court. On June 29, 1989, Sundara and MSA were enjoined by the U.S. District Court for the Northern District of Illinois for violating the antifraud provisions of the Securities Act of 1933, Securities Exchange Act of 1934 and Investment Advisers Act of 1940, as well as the registration and books and records provisions of the Advisers Act. Finally, the Commission found that Sundara and MSA violated these various provisions of the federal securities laws. (Rel. 34-28419)

### CIVIL PROCEEDINGS

### COMPLAINT NAMES WILLIAM GOTCHEY AND JOHN WHITLEY

The Philadelphia Regional Office announced that, on September 14, the Commission filed a Complaint in the U.S. District Court for the Western District of Virginia against William S. Gotchey and John A. Whitley, seeking permanent injunctions against future violations of the antifraud provisions of the Securities Act, the Securities Exchange Act and the Investment Advisers Act, and disgorgement of \$15,000 from Gotchey. Without admitting or denying the allegations contained in the Complaint, Whitley has consented to the entry of a Final Judgment and Order granting the relief sought in the Complaint.

The Complaint alleges that from August 1987 to June 1988, Gotchey and Whitley, acting through First American Financial Consultants, Inc. (FAFC), a registered investment adviser, defrauded investors by utilizing misrepresentations and omissions of material fact to induce approximately twenty advisory clients to invest \$135,000 in a blind pool gold company. In addition, the Commission alleges that Gotchey fraudulently induced an FAFC advisory client to invest \$15,000, by misrepresenting to the client that the funds would be invested in mortgage-backed securities. ## INVESTMENT COMPANY ACT RELEASES

### DOLPHIN FRIC CONVERTIBLE FUND

A notice has been issued giving interested persons until October 10 to request a hearing on an application filed by Dolphin FRIC Convertible Fund for an order under Section 8(f) of the Investment Company Act declaring that it has ceased to be an investment company. (Rel. IC-17740 - September 13)

### SELF-REGULATORY ORGANIZATIONS

### PROPOSED RULE CHANGES

On August 20, the <u>National Association of Securities Dealers</u> (SR-NASD-90-49) filed a proposed rule change which would amend the PORTAL Rules to conform to the final version of Rule 144A. The proposal would delete the requirements restricting the exit of PORTAL securities from the PORTAL Market to non-PORTAL accounts. Publication of the rule change is expected in the <u>Federal Register</u> during the week of September 10. (Rel. 34-28429)

On August 24, the <u>National Association of Securities Dealers</u> (SR-NASD-90-50) filed a proposed rule change which would amend the PORTAL Rules to conform to the final version of Rule 144A. The proposal would delete the requirement that the account of a PORTAL dealer, broker or qualified investor at its agent, providing it access to the PORTAL depository organization, be a segregated account for PORTAL Market transactions. Publication of the rule change is expected in the <u>Federal Register</u> during the week of September 10. (Rel. 34-28430)

On August 20, the MBS Clearing Corporation (SR-MBSCC-90-05) filed a proposed rule change pursuant to Rule 19b-4 of the Securities Exchange Act. MBSCC's proposal would establish a minimum market margin differential deposit requirement for its participants and would revise MBSCC's method of calculating the amount of such requirement. Notice of MBSCC's proposal is expected in the Federal Register during the week of September 17. (Rel. 34-28431)
