INSIDER TRADING COMPLAINT AGAINST RICHARD NAULT

On September 28, the Boston Regional Office filed a civil complaint in the U.S. District Court for the District of New Hampshire charging Richard M. Nault (Nault) with insider trading. The complaint alleges that Nault, an automotive dealer residing in Bedford, New Hampshire purchased Coastal Savings Bank (Coastal) stock while in possession of material non-public information misappropriated from Suffield Bank. The information concerned a proposed merger between Coastal and Suffield Bank. The complaint seeks disgorgement of trading profits of \$21,407.95 with prejudgment interest, plus a penalty of up to three times the profit gained. [SEC v. Richard M. INVESTMENT COMPANY ACT RELEASES

DEAN WITTER CAPITAL PARTNERS

An order has been issued to Dean Witter Capital Partners, L.P., et al., granting an exemption under Section 6(c) of the Investment Company Act from the provisions of Sections 2(a)(19) and 2(a)(3)(D) of the Act. (Rel. IC-17798 - October 12)

HOLDING COMPANY ACT RELEASES

ENTERGY CORPORATION

A notice has been issued giving interested persons until November 5 to request a hearing on a proposal by Entergy Corporation (Entergy), a registered holding company, Arkansas Power & Light Company, Louisiana Power & Light Company, Mississippi Power & Light Company, New Orleans Public Service Inc. (collectively, Operating Companies), System Fuels, Inc., System Energy Resources, Inc. (SERI), Entergy Operations, Inc. and Entergy Services, Inc. (collectively, Participating Companies), whereby the Participating Companies would continue their participation in the Entergy system money pool through November 30, 1992. In addition, the Operating Companies and SERI propose to issue short-term notes to banks and commercial paper to commercial paper dealers. (Rel. 35-25167)

SELF-REGULATORY ORGANIZATIONS

APPROVAL OF PROPOSED RULE CHANGES

The Commission approved two proposed rule changes filed by the National Association of Securities Dealers under Rule 19b-4 of the Securities Exchange Act: SR-NASD-90-45 to amend the Form U-4 to provide for a previously registered person, who is transferring his registration to another broker-dealer, to certify that he has reviewed a copy of his disclosure information taken from the Central Registration Depository (CRD) system, and that the information is accurate, complete and in Disclosure Reporting Page (DRP) format. There are three certification alternatives available to an individual and new DRPs only need to be filed when there is new information or information which must be updated (Rel. 34-28534); and SR-NASD-90-38 to establish a permanent charge of \$50.00 per month for subscribers to the National Quotation Data Service (NQDS). The NQDS Service will incorporate individual market maker quotations, Level 1 or "inside" quotations in NASDAQ and NASDAQ/NMS Last Sale information into a combined feed that will be supplied to NQDS vendors (Rel. 34-28539).

ACCELERATED TEMPORARY APPROVAL OF PROPOSED RULE CHANGE

The Commission granted accelerated approval to a proposed rule change filed by the New York Stock Exchange (SR-NYSE-90-50) to extend the pilot program that eliminates differentials and floor brokerage charges for certain odd-lot orders executed through the NYSE's automated system until January 31, 1991. Persons eligible to use the short form (Schedule 13G) may in lieu of filing a Schedule 13D file a Schedule 13G within 45 days after the end of the calendar year in which the person became subject to Section 13(d)(1). Companies and individuals making a tender offer must have on file at the time the tender offer commences a Schedule 14D-1.
