ENFORCEMENT PROCEEDINGS

BROKER BARRED

In administrative proceeding No. 3-9355, Ted Harold Westerfield, Judge G. Marvin Bober found that the Respondent, Ted Harold Westerfield, violated Section 15(b)(6) of the Securities Exchange Act of 1934. Judge Bober's decision was based, in large measure, upon the Respondent's federal criminal and civil convictions.

The illegal activity occurred in the year 1990. This case involved a fraudulent commission kickback scheme between the Respondent, who worked as a broker for a brokerage firm and another individual, a bond analyst and assistant portfolio manager for a fund. Under the scheme, the Respondent would purchase and sell certain high yield securities at the analyst's request. As a result, the Respondent received over \$209,600 in commissions, and he kicked back to the analyst approximately \$35,000.

Based on the violations and public interest considerations, Judge Bober barred the Respondent from association with any broker or dealer, with a right to reapply for such association five years after the date of the initial decision.

Judge Bober did not impose a collateral bar against the Respondent. Judge Bober was of the opinion that the violations did not meet the threshold test necessary to impose a collateral bar as mandated in the Commission's decision in Meyer Blinder, 65 SEC Docket 1970 (Oct. 1, 1997). COMMISSION OBTAINS PRELIMINARY INJUNCTION AGAINST NICHOLAS ZAHAREAS, TUSCHNER & COMPANY, INC. AND JOHN TUSCHNER

On January 20, 1998, the U.S. District Court for the District of Minnesota entered a preliminary injunction commanding Nicholas Zahareas (Zahareas), a U.S. citizen residing in Greece, to comply with a July 1993 Commission order barring him from association with any broker or dealer. The preliminary injunction also enjoined Zahareas, Tuschner & Company, Inc. (Tuschner & Co.) and John M. Tuschner (Tuschner) from future violations and aiding and abetting violations of Sections 15(b)(6)(B)(i) and (ii) of the Securities

Exchange Act of 1934. The Court found that Zahareas violated the Commission bar order and wrongfully associated with Tuschner & Co., a Minneapolis broker-dealer registered with the Commission, by acting as a Tuschner & Co. registered representative in all but name. Zahareas acted as Tuschner & Co.'s registered representative by, among other things, directing over \$9 million worth of trading in customer accounts and receiving commissions on those trades. In addition, the Court found that Tuschner & Co. wrongfully allowed Zahareas to associate with it and that Tuschner, the Chairman and CEO of Tuschner & Co., knew of Zahareas' bar and aided and abetted his wrongful association.
