ENFORCEMENT PROCEEDINGS

SETTLEMENT FILED IN INSIDER TRADING CASE AGAINST KARLA DORSCH

Today the Commission announced that Karla Dorsch, a defendant in a major insider trading case filed in May 1994, has without admitting or denying the allegations against her, consented to the entry of a court order permanently enjoining her from future violations of antifraud provisions of federal securities laws; requiring her to disgorge unlawful profits realized by herself and her tippees, payment of all but \$70,000 to be waived based upon her demonstrated inability to make full payment. The order was entered by U.S. District Court Judge Shira A. Schendlin on July 14, 1998.

The complaint alleged that Karla Dorsch and her then husband Carlos Roman were tipped by Lee A. Haddad, an analyst employed at Morgan Stanley & Co., Inc., to five planned corporate acquisitions involving among others, Combustion Engineering, Inc. The complaint alleged that Roman and Karla Dorsch made \$714,118.75 in illegal insider trading profits and that they tipped Karla's father, William E. Dorsch, who made \$1,083,250 in unlawful profits; and that Roman tipped his broker Andrew Cohen who made \$300,233.81 in illegal profits. Haddad and Cohen previously settled the action against them without admitting or denying the substantive allegations (see LR-13473). Karla Dorsch is awaiting sentencing in a related criminal case. INVESTMENT COMPANY ACT RELEASES

SEI LIQUID ASSET TRUST, ET AL.

An order has been issued on an application filed by SEI Liquid Asset Trust, et al., under Section 17(d) of the Investment Company Act and Rule 17d-1 under the Act. The order permits certain registered open-end management investment companies to deposit uninvested cash balances in joint accounts investing in short-term repurchase agreements. (Rel. IMMEDIATE EFFECTIVENESS OF PROPOSED RULE CHANGE

A proposed rule change filed by the <u>Municipal Securities Rulemaking Board</u> to modify the Board's fees relating to the operation of its Official Statement/Advance Refunding Document subsystem (SR-MSRB-98-7) became effective under Section 19(b)(3)(A) of the Securities Exchange Act of 1934.
