INVESTMENT COMPANY ACT RELEASES

THE DREYFUS/LAUREL TAX-FREE MUNICIPAL FUNDS

An order has been issued on an application filed by The Dreyfus/Laurel Tax-Free Municipal Funds (Trust) under Section 17(b) of the Investment Company Act granting an exemption from Section 17(a) of the Act. The order permits a series of the Trust to acquire all of the assets and assume all the liabilities of two other series of the Trust. (Rel. IC-23529 - November 10)

FORMUS COMMUNICATIONS, INC., ET AL.

An order has been issued on an application filed by Formus Communications, Inc. and Formus International, Inc. under Section 6(c) of the Investment Company Act to permit applicants and certain of their controlled companies to participate in certain foreign telecommunications ventures without being subject to the provisions of the Act. (Rel. IC-23530; International Series Rel. 1169 - November 10)

THE VICTORY PORTFOLIOS AND KEY ASSET MANAGEMENT, INC.

An order has been issued on an application filed by The Victory Portfolios and Key Asset Management, Inc. under Section 12(d)(1)(J) of the Investment Company Act for an exemption from Section 12(d)(1) of the Act, and under Sections 6(c) and 17(b) of the Act for an exemption from Section 17(a) of the Act. The order supersedes a prior order and permits applicants to implement a "fund of funds" arrangement. In addition to the fund of funds investing in other funds in the same group of investment companies, the order permits the fund of funds to invest a portion of its assets in funds that are not part of the same group of investment companies in reliance on Section 12(d)(1)(F) of the Act. The order also allows the fund of funds to offer its shares to the public with a sales load that exceeds the 1.5% limit of Section 12(d)(1)(F)(ii). (Rel. IC-23531 - November 10)

SELF-REGULATORY ORGANIZATIONS

IMMEDIATE EFFECTIVENESS OF PROPOSED RULE CHANGE

On November 2, NASD Regulation, Inc. filed a proposed rule change (SR-NASD-98-82) to increase the review charge for advertisements, sales literature and other such material. The fee increase will become effective on January 1, 1999. Publication of the proposal is expected in the Federal Register during the week of November 16. (Rel. 34-40653)

APPROVAL OF PROPOSED RULE CHANGE

The Commission approved a proposed rule change filed by the National Securities Clearing Corporation (SR-NSCC-98-06) that amends NSCC's rules and procedures regarding the automated customer account transfer service. (Rel. 34-40657)
