## DECISIONS IN ADMINISTRATIVE PROCEEDINGS

SUSPENSION OF REGULATION A EXEMPTION OF WORLD WHOLESALE, INC., MADE PERMANENT.

An order has been issued making permanent the suspension of the claimed Regulation A exemption from the Securities Act's registration requirements for an offering of 1,000,000 shares of the common stock of World Wholesale, Inc., of Salt Lake City, Utah.

The Commission's temporary suspension order alleged that World Wholesale's offering circular was materially false and misleading with respect to the actual and undisclosed underwriters of the offering, undisclosed promoters, the use to be made of the proceeds of the offering, world wholesale's actual business, and the plan by which the securities were to be distributed. Moreover, offering circulars were not furnished to all purchasers of world wholesale's stock

World Wholesale neither filed an answer nor asked for a hearing. The underwriter of the offering did answer and also asked for a hearing. But it subsequently consented to a permanent suspension. (Rel. 33-5503)

## ORDERS FOR PUBLIC PROCEEDINGS

LAIDLAW & CO., INC., OTHERS

Public administrative proceedings have been ordered against 21 respondents based on charges of violations of the securities laws, primarily in an unsuccessful public offering of 200,000 shares of SaCom stock on October 31, 1972. Named as respondents were the managing underwriter, Laidlaw & Co., Inc. (now known as LAC, Inc.) and Rollin F. Perry, the former head of Laidlaw's corporate finance division; two market makers in SaCom stock, A. P. Montgomery and Torpie & Saltzman, Inc.; and eight of the participating underwriters in the SaCom offering, namely, Mitchum Jones & Templeton, Sterling Grace & Co., Inc., Filor, Bullard & Smyth, Pitfield Mackey & Co., Inc., Mack Bushnell & Edelman, Inc., Roberts, Scott & Co., Henry F. Swift & Co., and Brown, Allen, Rose & Co., Inc.; as well as the legal counsel for SaCom, Leo E. Bromberg. The Commission also named NDF Securities, Inc. and seven individuals in connection with trading activities in SaCom (Richard S. Friedman of A. P. Montgomery; Harvey Geller, James Torpie, David Saltzman of Torpie & Saltzman; Bernard G. Bizar of NDF Securities; Frank Harrison and Douglas Watson of Brown, Allen & Co.)

It is alleged that Laidlaw and Perry, in the SaCom offering, engaged in manipulative activities to facilitate the distribution of the SaCom offering and to create the false impression that the offering had been successfully distributed to the public. The Commission Staff charged violations of the antifraud, registration, and record keeping provisions of the securities laws. Laidlaw, Perry, and others are also charged with violations in trading activities in the common stock of Manchester Life and Casualty Management Corp. and Dynalectron Corp. (Rel. 34-10875)

### COURT ENFORCEMENT ACTIONS

EDWARD BARANOV, DAVID A. TOPPING ENJOINED

The Los Angeles Regional Office announced that on June 4 the Federal Court in San Diego permanently enjoined Edward Baranov, a San Diego accountant, and David

Alvin Topping, a former securities broker-dealer from violating the registration and antifraud provisions of the securities laws in the offer and sale of stock of Patterson Corporation. Baranov and Topping consented to the court orders without admitting or denying the allegations. (LR-6406)

CONTINENTAL SILVER CORPORATION OF NEVADA, CONTINENTAL SILVER CORPORATION, A COLORADO CORPORATION, ENJOINED

The Denver Regional Office, announced that on June 17 the Federal court for Colorado preliminarily enjoined Continental Silver Corporation of Nevada and Continental Silver Corporation, a Colorado corporation, from violations of the registration and antifruad provisions of the securities laws in the offer and sale of securities issued by Continental Silver Corporation, a California corporation, and the defendants. The court allowed an additional period of time for defendants Louis C. Schiess and Frank G. Congleton to consult with their attorneys concerning the possibility of resolving some of the issues in the case. The Nevada and Colorado corporations were ordered to make an accounting of all investor funds received, the uses to which such funds were put, and the amounts and location of any remaining such funds. The corporations were also enjoined from destroying, altering, transferring or in any way disposing of the books, records, documents, funds or assets of those corporations. Jack Smock previously consented to the injunction without admitting or denying the allegations. Effective service has not yet been made on Chess Wilburn Barr, III, the president of the corporation. (LR-6407)

#### DEAN WITTER TAX-EXEMPT TRUST

A notice has been issued giving interested persons until July 16 to request a hearing on an application of The Dean Witter Tax-Exempt Trust, First Series (and Subsequent Series), a unit investment trust. The Trust requests exemption from the initial net worth requirements, the dividend distribution limitations and the pricing requirements of the Act with respect to secondary market operations of its sponsor and granting confidential treatment to profit and loss statements of the sponsor.
