COMMISSION ANNOUNCEMENTS

COMMISSION ACTION ON FOIA APPEAL

LIBRARY

The Commission has affirmed the staff's initial disposition of a request under the Freedom of Information Act (FOIA) of Todd & Company, Inc. and Thomas K. Langbein, who had requested materials relating to certain policies of the National Association of Securities Dealers, Inc. (NASD) which, it was claimed, the NASD would be required to maintain and either publish or make publicly available if the NASD were an "agency" as that term is defined in the FOIA. The Commission held that the staff correctly took the position, in responding to this request, that the NASD is not an "agency" of the federal government. Since the staff offered the requesters access to all requested documents in the actual possession of the Commission, subject to the authorization of the search which would be required to locate these records, the staff's disposition of this request fully complied with the requirements of the Freedom of Information Act. COURT ENFORCEMENT ACTIONS

CHRISTOS L. NETELKOS, OTHERS, SENTENCED

The New York Regional Office announced that on January 12 Honorable Herbert J. Stern, U.S. District Court Judge for the District of New Jersey sentenced five individuals to prison in connection with the collapse of Christian-Paine and Co., Inc., a registered broker-dealer.

The sentences, on conviction for conspiracy, hypothecation, unlawful sales of securities, bookkeeping violations and related charges, were as follows: Christos L. Netelkos, Clifton, New Jersey, 11 years in prison and \$50,000 fine; Joseph J. Rega, Fairfield, New Jersey, 5 years in prison and \$20,000 fine; Charles H. Gamarekian, Clifton, New Jersey, 5 years in prison and \$20,000 fine; George Santoriello, Hillside, New Jersey, 18 months in prison; and Georgette Ysrael, Hasbrouck Heights, New Jersey, 18 months in prison. COMPLAINT NAMES WESTERN ORBIS COMPANY

The SEC announced the filing of a complaint in the U.S. District Court for the District of Columbia on January 21, seeking a court order directing Western Orbis Company (Western Orbis), Los Angeles, California, to comply with the reporting provisions of the Securities Exchange Act of 1934 and seeking a permanent injunction against further such violations.

According to the Commission's complaint against Western Orbis, the company failed to file with the Commission in proper form its annual report on Form 10-K for its fiscal year ended June 30, 1975, and its quarterly report on Form 10-Q for the quarter ended September 30, 1975. INVESTORS SYNDICATE OF AMERICA, INC.
