## ENFORCEMENT PROCEEDINGS

---

COMPLAINT FILED AGAINST UNITED FIRE TECHNOLOGY, INC., BEVERLEE KAMERLING, WWBM CONSULTANTS, INC., JAMES GARTLAND, CHARLES JONES, MICHAEL HOOPER AND KENNETH STARNES

The Commission announced that it filed a complaint against United Fire Technology, Inc., James Gartland, Beverlee Kamerling, WWBM Consultants, Inc., Michael Hooper, Kenneth Starnes, and Charles F. Jones. The complaint alleges as follows:

From approximately July 1994 through December 1995, UFT conducted an unregistered distribution of common stock, and Kamerling, WWBM, and Jones illegally sold UFT's stock to the investing public raising approximately \$1,350,000 in proceeds. In connection with this stock selling effort, Jones acted as an unregistered broker. While the stock was being sold, UFT, Kamerling, Gartland, and Hooper made materially false and misleading statements, and failed to disclose material information to investors concerning UFT and its alleged "Flamex" fire-fighting products. Finally, UFT, through Kamerling, paid compensation to Starnes, a broker, to sell UFT common stock to his customers, and Starnes did not disclose this compensation.

The complaint alleges violations of Sections 5 and 17(a) of the Securities Act of 1933 and Sections 10(b) and 15(a) of the Securities Exchange Act of 1934 and Rule 10b-5 thereunder. The complaint seeks permanent injunctive relief against all defendants, disgorgement from UFT, Kamerling, WWBM, Starnes and Jones, and an officer and director bar against Kamerling. [SEC v.
