### COMMISSION ANNOUNCEMENTS

THE SEC SEEKS INPUT REGARDING CORPORATE CHARITABLE GIVING DISCLOSURE AND DECISIONMAKING

The Commission announced today that it is issuing an invitation to the public to comment on matters related to charitable giving by public companies. The SEC is studying these issues at Congress' request in connection with pending legislation about charitable contributions by public companies. In general, one bill would require public companies to disclose their charitable contributions and a second bill would require each public company to allow its shareholders to participate in deciding which charities the company should contribute to and how much to contribute. ### INVESTMENT COMPANY ACT RELEASES

REICH & TANG DISTRIBUTORS L.P., ET AL.

An order has been issued on an application filed by Reich & Tang Distributors L.P., et al. for an order under Section 6(c) of the Investment Company Act exempting applicants from Sections 2(a)(32), 2(a)(35), 22(d), and 26(a)(2) of the Act and Rule 22c-1 under the Act. The order permits certain unit investment trusts to impose a deferred sales charge on trust units and to waive the charge in certain instances. (Rel. IC-22866 - October 29)

TCW INTERNATIONAL EQUITY LIMITED PARTNERSHIP, ET AL.

An order has been issued on an application filed by TCW International Equity Limited Partnership, et al. under Section 17(b) of the Investment Company Act for an exemption from Section 17(a) of the Act. The order permits certain limited partnerships to transfer all of their assets to corresponding series of a registered

investment company in exchange for the series' shares, which then will be distributed <u>pro rata</u> to partners of the partnerships. (Rel. IC-22867 - October 29)

## HOLDING COMPANY ACT RELEASES

NEW ENGLAND ELECTRIC SYSTEM, ET AL.

An order has been issued authorizing a proposal by New England Electric System (NEES), a registered holding company, and its subsidiary companies Granite State Electric Company, Massachusetts Electric Company (Mass. Electric), Nantucket Electric Company (Nantucket), The Narragansett Electric Company (Narragansett), New England Electric Narragansett Energy Resources Company, Transmission Corporation, New England Energy Incorporated, New England Hydro-Transmission Electric Company, Inc. (Mass. Hydro), New England Hydro-Transmission Corporation, New England Power Company (NEP), and New England Power Service Company (NEPSCO) (collectively, Applicants). Applicants propose, for the period from November 1, 1997 through October 31, 2001, that: (i) Mass. Electric, Nantucket, Narragansett, Mass. Hydro, NEP, and NEPSCO (Borrowing Companies) borrow from the NEES intrasystem money pool (Money Pool); (ii) any one Applicant, or a combination of several Applicants, loan money to one or more of the Borrowing Companies through the Money Pool under the current terms of the Money Pool; (iii) the Borrowing Companies borrow from banks; and (iv) Mass. Electric, Narragansett, and NEP issue commercial paper. (Rel. 35-26768)
