EXCHANGE COMMISSION

ADMINISTRATIVE PROCEEDINGS

JOSEPH-SEP GRAHAM BARRED

The Commission has issued an Order Instituting Public Administrative Proceedings, Making Findings and Imposing Remedial Sanctions against Joseph-Sep S. Graham, a former principal associated with a registered broker-dealer and a registered investment adviser. Simultaneously with the institution of the proceedings, the Commission accepted an Offer of Settlement from Graham wherein he admitted to certain findings and consented to the sanction imposed. Graham consented to the issuance of an Order containing findings that he was convicted, based on his plea of guilty, of one count of mail fraud in violation of 18 U.S.C. Section 1341. In addition, the Commission found that at the time of Graham's criminal violations he was associated with a registered broker-dealer and with a registered investment adviser.

The Order bars Graham from association with any broker, dealer, municipal securities dealer, investment company or investment adviser. (Rel. 34-30483; IA-1303)

CIVIL PROCEEDINGS

COMPLAINT FILED AGAINST FRANK WAGNER, FERNANDO ROJAS AND LEOBARDO LOZA

On March 20, the Commission announced the filing of a complaint against Frank Wagner, Fernando Rojas and Leobardo Loza for violations of Section 10(b) of the Securities Exchange Act of 1934 and Rule 10b-5 thereunder in connection with trading by Loza and Wagner in the securities of Boys Markets, Inc., a supermarket chain based in Los Angeles, California.

The complaint alleges that in February 1988 Rojas obtained nonpublic information about a likely acquisition of Boys Markets through his position as controller of the acquiring company. Rojas tipped his friend Loza, who traded in advance of the public announcement of the proposed acquisition, and gave a portion of his \$17,743 profit to Rojas. The complaint also alleges that Loza in turn tipped Wagner, who also traded

in advance of the public announcement, and gave \$2,000 of his \$21,900 profits to Loza. Simultaneously with the filing of the complaint, Loza and Rojas each consented to the entry of a permanent injunction against future violations and agreed to disgorge their trading profits (\$12,743 by Rojas and \$7,000 by Loza) together with prejudgment interest and penalties under the Insider Trading Sanctions Act of 1984. Wagner has not settled the charges brought against him.

This matter was referred to the Commission by the National Association of Securities Dealers, Inc. [SEC v. Frank Wagner, Fernando Rojas and Leobardo Loza, Civil Action No. 92-1713 WMB, KX, USDC, C.D. CA] (LR-13196)

INVESTMENT COMPANY ACT RELEASES

AMERICAN INVESTMENT TRUST

A notice has been issued giving interested persons until April 13 to request a hearing on an application filed by American Investment Trust for an order under Section 8(f) of the Investment Company Act declaring that it has ceased to be an investment company. (Rel. IC-18618 - March 19)

SELF-REGULATORY ORGANIZATIONS

APPROVAL OF PROPOSED RULE CHANGE

The Commission has approved a proposed rule change filed by The Depository Trust Company (SR-DTC-91-20) to allow broker-dealers to exchange trade data through the ID and IID systems for transactions that will settle outside the automated settlement systems. Publication of the approval order is expected in the Federal Register during the week of March 23. (Rel. 34-30496)

The Commission has approved a proposed rule change filed by The Options Clearing Corporation (SR-OCC-92-01) that revises the Canadian Clearing Fund Depository Receipt and Security Agreement and the Canadian Margin Depository Receipt and Security Agreement to permit OCC and its Canadian clearing agent bank to accept facsimile transmissions of Canadian depository receipts. Publication of the approval order is expected in the Federal Register during the week of March 23. (Rel. 34-30500; International Series Rel. 374)

IMMEDIATE EFFECTIVENESS OF PROPOSED RULE CHANGE

A proposed rule change (SR-NSCC-92-1) filed by The National Securities Clearing Corporation to revise its fee schedule has become effective immediately upon filing with the Commission. Publication of the proposal is expected in the Federal Register during the week of March 23. (Rel. 34-30498)

PROPOSED RULE CHANGE

The New York Stock Exchange filed a proposed rule change (SR-NYSE-92-05) to amend its interpretation of NYSE Rule 452 to give member organizations a "may vote" in respect of initial approvals of investment company contracts. Publication of the proposal is expected in the Federal Register during the week of March 23. (Rel. 34-30499)
