## CIVIL PROCEEDINGS

---

### SUMMARY JUDGMENT GRANTED AGAINST MICHEAL GRUENBERG

The Commission announced that Summary Judgment was granted and a Final Judgment and Order of Permanent Injunction entered against Micheal L. Gruenberg by the U.S. District Court for the District of Minnesota, enjoining him from violations of the antifraud, reporting and accounting provisions of the Securities Exchange Act of 1934. Micheal Gruenberg was formerly a director and president of Endotronics, Inc., a Minneapolis based biotechnology company.

The complaint, which was filed on May 28, 1991, alleged that in 1986 and 1987 Micheal Gruenberg, along with Eugene I. Gruenberg, formerly Endotronics' chairman and chief executive officer, engaged in a scheme to inflate Endotronics' revenue by reporting false sales and engaging in several undisclosed related party transactions which involved their secretly infusing funds into the company. Micheal and Eugene Gruenberg were both convicted by a U.S. District Court in October 1990 of various counts of violating federal wire, mail and securities laws in connection with the alleged scheme and sentenced to prison.

On or about January 9, 1992, the Commission moved for summary judgment against both defendants, which was granted on July 1, 1992 by the Honorable Harry H. MacLaughlin, U.S.D.C. Judge, with respect to Micheal L. Gruenberg. [SEC v. Micheal L. Gruenberg, et al., Civil Action No. 5-91-CV-68, USDC, D. Minn.] (LR-13302; AAE Rel. 411)

### CIVIL ACTION AGAINST LATIN INVESTMENT CORP., ET AL.

The Commission announced today that the U.S. District Court for the District of Columbia last week entered an order and final judgment of permanent injunction and other relief against Fernando Leonzo (Leonzo), the former president of Latin Investment Corporation. The Court found that Leonzo violated Sections 5(a) and (c) of the Securities Exchange Act of 1933 (Securities Act) by selling unregistered securities, in the form of passbook accounts, to investors. The Court further found that Leonzo violated Section 17(a) of the Securities Act and Section 10(b) of the Exchange Act of 1934 (and Rule 10b-5 thereunder) by, among other things, misrepresenting to investors that Latin Investment Corporation was a bank and failing to tell investors that he used investors' funds for his own personal benefit in connection with sales of the passbook accounts. The Court ordered Leonzo to pay disgorgement and restitution of \$6,461,266.91 and prejudgment interest of \$965,214. [SEC. v. Latin Investment Corp., et. al., USDC DC, 90 Civ. 3101, GAG] (LR-13304)

## CRIMINAL PROCEEDINGS

---

### JOHN GENETTI AND LOUIS VARGAS INDICTED

The Commission and the U.S. Attorney for the Central District of California announced that on June 11, 1992 John A. Genetti (Genetti) and Louis Vargas (Vargas) were indicted and charged with racketeering and securities fraud in connection with a scheme to defraud investors through the sale of approximately \$35,000,000 worth of bogus municipal bonds. The Indictment charges that Genetti and Vargas violated Section 10(b) of the Securities Exchange Act of 1934 and Rule 10b-5 thereunder by misrepresenting, among other things, that securities sold by Reserve Financial Group, First Securities Group of California, Inc. and FSG Financial Services, Inc. (FSG) were municipal bonds issued, backed or sanctioned by various governmental entities.

In a related civil case, the Commission filed an action in July 1991 against FSG and Joan S. Kantor (Kantor) alleging fraud in connection with the sale of securities misrepresented to be municipal bonds. The Court has entered a preliminary injunction against FSG and Kantor, and has ordered other relief. [SEC v. FSG Financial Services, Inc. and Joan S. Kantor, Civil Action No. 91-3960 JM] (LR-13303)

## INVESTMENT COMPANY ACT RELEASES

---

### THE ADVANTAGE GROWTH AND TREASURY SECURITIES TRUST, ET AL.

The Advantage Growth and Treasury Securities Trust, et al. (Advantage) have been issued a conditional order under Section 6(c) of the Investment Company Act for an exemption from Section 12(d)(1) to permit certain unit investment trusts to invest in shares of one of certain mutual funds and zero coupon obligations. The conditional order also exempts Advantage from Section 14(a) to exempt the trust sponsor from having to take for its own account or place with others \$100,000 worth of units in the trusts. In addition, Advantage is exempted from Section 19(b) and Rule 19b-1 to permit the trusts to distribute capital gains resulting from redemption of fund shares within a reasonable time after receipt. Further, Advantage is exempted from Section 22(d) to permit waiver of any sales load otherwise applicable on fund shares that the trusts have purchased; under Sections 11(a) and (c) to permit certain offers of exchange involving the trusts; and under Section 17(d) and Rule 17d-1 permitting certain affiliated transactions involving the trusts. ### SHEARSON LEHMAN APPRECIATION FUND, ET AL.

An order has been issued on an application filed by Shearson Lehman Appreciation Fund, et al. under Section 6(c) of the Investment Company Act granting an exemption from Sections 2(a)(32), 2(a)(35), 18(f), 18(g), 18(i), 22(c), and 22(d) of the Act and Rule 22c-1 thereunder. The exemption permits applicants to issue three classes of shares representing interests in the same portfolio of securities, and to assess a contingent deferred sales load (CDSL) on certain redemptions of shares of one of the classes, and to waive the CDSL in certain cases. (Rel. IC-18832 - July 7)

WADDELL & REED FUNDS, INC., ET AL.

A conditional order has been issued under Section 6(c) of the Investment Company Act exempting Waddell & Reed Funds, Inc., et al. from the provisions of Sections 2(a)(32), 2(a)(35), 22(c), and 22(d) of the Act and Rule 22c-1 thereunder. The exemption permits applicants to impose a contingent deferred sales charge (CDSC) on redemptions of the fund's shares and to waive the CDSC under certain circumstances. (Rel. IC-18833 -July 7)
