SELF-REGULATORY ORGANIZATIONS

PROPOSED RULE CHANGE

The Chicago Board Options Exchange filed a proposed rule change (SR-CBOE-92-14) to permit trading in Buy-Write Options Unitary Derivatives (BOUNDS), long-term options with a duration of up to 60 months which have the same economic characteristics as covered calls. The CBOE also proposes to amend its existing rules to permit the listing of long-term equity options (LEAPs) with a duration of up to 60 months. Publication of the proposal is expected in the Federal Register during the week of April 17. (Rel. 34-31047)

ACQUISITION OF SECURITIES

Companies and individuals must report to the Commission within ten days on Schedule 13D if after the acquisition of equity securities of a public company their beneficial interest therein exceeds five percent. Persons eligible to use the short form (Schedule 13G) may in lieu of filing a Schedule 13D file a Schedule 13G within 45 days after the end of the calendar year in which the person became subject to Section 13(d)(1). Companies and individuals making a tender offer must have on file at the time the tender offer commences a Schedule 14D-1.
