## INVESTMENT COMPANY ACT RELEASES

---

### TECHNOLOGY FUNDING MEDICAL PARTNERS I, L.P., ET AL.

A notice has been issued giving interested persons until January 22, 1993 to request a hearing on an application filed by Technology Funding Medical Partners I (Partnership), Technology Funding Inc., and Technology Funding Ltd. for a conditional order. The order would determine that the independent general partners of the Partnership are not "interested persons" of the Partnership, the other general partners, or the principal underwriter of the Partnership solely by reason of their status as general partners of the Partnership and co-partners of the other general partners. The order would also determine that no limited partner owning less than five percent of the units of limited partnership interest in the Partnership is an "affiliated person" of the Partnership or any of its partners solely by reason of being a limited partner of the Partnership and a co-partner of the other limited partners and the general partners. ### AMERITAS VARIABLE LIFE INSURANCE COMPANY, ET AL.

An order has been issued to Ameritas Variable Life Insurance Company (Ameritas), AVLIC Separate Account V (Ameritas Account), Fidelity Investments Life Insurance Company (Fidelity Life), The Fidelity Investments Variable Life Account I (Fidelity Account), Midland National Life Insurance Company (Midland), Midland National Life Separate Account A (Midland Account), Monarch Life Insurance Company (Monarch), The Fidelity Variable Account (Monarch Account), Vermont Life Insurance Company (Vermont), and Vermont Variable Life Insurance Account (Vermont Account), pursuant to Section 26(b) of the Investment Company Act. The order approves the substitution of certain securities issued by the Variable Insurance Products Fund and by the Variable Insurance Products Fund II, and held by Ameritas Account, Fidelity Account, Midland Account, Monarch Account, and Vermont Account to fund variable life insurance contracts issued by Ameritas, Fidelity Life, Midland, Monarch, and Vermont, for securities issued by the Zero Coupon Bond Fund. ### THE PARK AVENUE PORTFOLIO

A notice has been issued giving interested persons until January 25, 1993 to request a hearing on an application filed by The Park Avenue Portfolio for a conditional order under Section 6(c) of the Investment Company Act exempting applicant from the provisions of Section 12(d)(3) of the Act. The exemption would apply to the extent necessary to permit it to invest in equity and convertible debt securities of foreign issuers engaged in securities-related activities, provided such investments comply with proposed amended Rule 12d3-1 under the Act. (Rel. IC-19187; International Series Rel 515 - December 29)

MORGAN STANLEY FUND, INC., ET AL.

A conditional order has been issued on an application filed by Morgan Stanley Fund, Inc., et al. for an order under Section 6(c) of the Investment Company Act exempting applicants from the provisions of Sections 2(a)(32), 2(a)(35), 18(f), 18(g), 18(i), 22(c), and 22(d) of the Act and Rule 22c-1 thereunder. The order permits applicants to issue multiple classes of shares representing interests in the same portfolio of securities and assess a contingent deferred sales charge (CDSC) on certain redemptions of shares and waive the CDSC in certain cases. (Rel. IC-19189 - December 29)

IDS BOND FUND, INC., ET AL.

A conditional order has been issued under Section 6(c) of the Investment Company Act exempting IDS Bond Fund, Inc., et al. from the provisions of Section 12(d)(3) of the Act and Rule 12d3-1 thereunder. The exemption applies to the extent necessary to permit them to invest in equity and convertible debt securities of foreign issuers engaged in securities-related activities in accordance with the conditions of the proposed amendments to Rule 12d3-1. (Rel. IC-19190; International Series Rel 516 - December 29)

## ACQUISITION OF SECURITIES

---

Companies and individuals must report to the Commission within ten days on Schedule 13D if after the acquisition of equity securities of a public company their beneficial interest therein exceeds five percent. Persons eligible to use the short form (Schedule 13G) may in lieu of filing a Schedule 13D file a Schedule 13G within 45 days after the end of the calendar year in which the person became subject to Section 13(d)(1). Companies and individuals making a tender offer must have on file at the time the tender offer commences a Schedule 14D-1.

Below is a list of recent filings of Schedules 13D and 14D, which includes the following information: Column 1 - the company purchased (top), and the name of the purchaser; Column 2 - the type of security purchased; Column 3 - the type of form filed; Column 4 - the date the transaction occurred; Column 5 - the current number of shares (in 000's) owned (top) and the current percent owned; Column 6 - the CUSIP number (top) and the percent owned; and Column 7 - the status of the filing, i.e., new, update or revision.
