SUBJECT: Update of Security Assistance Management Manual (SAMM) Eligibility Listing for the Republic of Kosovo, DSCA Policy 08-13 [SAMM E-Change 105]

Effective immediately, SAMM Table C4.T2., Country, International Organization, and Regional Codes and Foreign Military Sales (FMS) Eligibility, is updated as below to reflect the Republic of Kosovo's eligibility to receive defense articles and services under the Foreign Assistance Act of 1961, as amended, and the Arms Export Control Act, as amended. Kosovo's eligibility derives from Presidential Determination 2008-15 of March 13, 2008.
